When surplus funds are available they are used to purchase and upgrade equipment, and invested back into the facility and services we provide to maintain high quality patient care. We continually strive to meet the healthcare needs within our community and the surrounding area. This merger has strengthened our abilities to serve the communities by providing us with a better physician &amp; mid-level recruitment platform and higher continuity of care. In striving to meet the needs of the communities we provide services including Assisted Living, Basic Care, Skilled Nursing, Medical &amp; Surgical Hospital, Rural Health Clinics, Surgical Clinic, and numerous other outpatient services and therapies. We have lost money on some of these services such as Cardiac Rehab, our Clinics, and our Hospice program but continue to maintain these services because of the needs within the communities. If we did not provide services such as these, the services would be unavailable in the community. Patients would have to go out of town to get the services which is not always possible, so some would not have access to these services if we did not provide them. In the spring 2017, we expect to open our Cancer Care Center. Currently we are not involved much in community building activities. Being a small CAH facility with limited resources, our focus is more on health related programs and services needed within our community. If we did not provide the service, it would not be available within the community.</p>
