THE FOUNDATION IS GOVERNED BY A VOLUNTEER BOARD OF DIRECTORS, IS REGISTERED AS A 501(c)(3) U.S. CHARITABLE ORGANIZATION AND LICENSED BY THE STATE OF NORTH DAKOTA. THE FOUNDATION EXISTS TO RAISE FUNDS FOR NEW EQUIPMENT AND TECHNOLOGY, DEVELOP NEW HEALTH RELATED PROGRAMS AND SERVICES, ENHANCE ASSISTED LIVING AND LONG-TERM CARE SERVICES, SUPPORT COMMUNITY WELLNESS EDUCATION, AND PROVIDE SCHOLARSHIPS AND LOANS FOR NURSING, ALLIED HEALTHCARE PROFESSIONALS AND PHYSICIANS TO MEET THE CONTINUING CHANGES IN HEALTHCARE REFORM.
