U S ProgramGlobal Alliance for Incinerator Alternatives provided technical and strategic support, resources, and information to dozens of members and allies in the U S as they worked to address pressing waste issues in their communities. We maintained an active members mailing list engaging more than 200 individuals and organizations in the U S. This year more than a dozen incinerator proposals were defeated including a major victory in Baltimore, Maryland. GAIA member Destiny Watford, a key leader in the Baltimore campaign, was awarded the Goldman Environmental Prize for her role in this work. GAIA continues to provide resources and connectivity to support Baltimore’s transition toward solutions organizing while leveraging their victory to achieve policy change and support other communities in similar struggles. GAIA continued to support the Boston Recycling Coalition in research, project development and policy planning. This year GAIA also joined a new coalition of Midwestern cities working to strengthen zero waste cities. We have been particularly involved in expanding zero waste systems in Detroit, Minneapolis, and Chicago. GAIA has also increasingly worked to provide technical support to new cities and communities adopting zero waste goals, and has advocated for city networks to ensure zero waste standards that do not include incineration. We specifically promote zero waste models that include worker justice, and this year GAIA co-released a major report highlighting the hazards facing recycling workers in the U S and calling on cities to improve health and safety standards in recycling sorting facilities. As a result of organizing and model sharing by GAIA and many other groups, in the past year, we have seen real positive movement toward zero waste among city leaders. At the U S Conference of Mayors in June 2015, the final resolution that was adopted had strong statements in favor of zero waste, with an emphasis on product redesign, reduction, and repair. In the lead-up to the release of the Clean Power Plan (CPP), GAIA joined the Climate Justice Alliance and our members across the U S in administrative advocacy for environmental justice and no-burn standards.

International Program The Global Alliance for Incinerator Alternatives uses a movement-building network model that empowers members to build their own capacity, facilitates international solidarity in response to local organizing efforts, and coordinates collective research and campaigns around issues of waste, pollution, climate, and economic justice. In this period, we worked closely with network members and other stakeholders in Argentina, Australia, Brazil, Canada, Chile, China, Colombia, Costa Rica, El Salvador, Indonesia, India, Japan, Mauntius, Mexico, Nicaragua, the Philippines, South Africa, Tanzania, the United States, and Uruguay, in addition to at least a dozen countries in the European Union, and engaged with numerous other countries in all regions of the world. We coordinated various international and regional list-serves reaching a substantial number of our 800+ global member organizations, and helped to link our members to expert resources for public events and environmental impact reviews. We continued to support the development and expansion of Zero Waste Europe, a sister network to GAIA that has legal status in the Netherlands. GAIA continues to support an increasing number of members who are leveraging local organizing against pollution into grassroots movements for environmental and economic justice and locally-rooted inclusive zero waste solutions. We organized and supported international zero exchanges in several countries, including a global meeting of 90+ members in Paris and a global gathering against cement kiln incineration in Montcada, Spain. These gatherings included skillshares, direct actions, sharing of best practices, and collaborative strategic planning. This year we also saw the formation of a new zero waste alliance in Chile, and the growth of the Network of Zero Waste Municipalities in Europe. At the same time, GAIA members around the world continue to protect the environment and public health by blocking the construction of incinerators in their communities and shifting political and financial drivers away from dirty energy. Dozens of incinerator proposals were blocked, and in the Philippines, GAIA and our members successfully blocked a bill that would have lifted the world’s only national ban on incinerators. GAIA members in Italy organized a 20,000-person strong protest against a proposed incinerator, effectively debunking the myth that incineration is popular in Europe. In the Philippines, GAIA has partnered closely with anti-coal and clean energy groups in upholding the ban on incineration. In the fall of 2015 we also collaborated with the Institute for Policy Studies in D C and a dozen other groups in producing a toolkit called Getting Climate Finance Right which highlights grassroots climate solutionsincluding three zero waste initiativesfrom around the world, and calls for a redirection of climate finance toward these projects. In the context of the 21st Conference of Parties in Paris, GAIA and our members were active in promoting real zero waste solutions that are happening in communities and cities around the world.

Plastics Program - This year GAIA launched a new global project focused on ending plastic pollution on land and in our oceans, with a particular focus on building and supporting impacted community organizing in the Asia Pacific region. GAIA aims to build the power of cities, zero waste practitioners, and grassroots environmental activists to challenge plastic pollution, and to demonstrate visionary, win-win solutions that protect public health, climate, and local economies. We are also working with new partners to develop collaborative corporate-facing strategies and policies to push for the redesign of products, packaging, and systems, which can be supported by our allies as well as by GAIA member organizations in many regions. Our network is a core supporter of the #breakfreefromplastics movement, and pre-work to establish this platform began this year.
