DURING THE FISCAL YEAR THAT ENDED ON MARCH 31,2016, JENKINS LIVING CENTER PROVIDED SKILLED NURSING AND REHABILITATION SERVICES FOR PEOPLE IN WATERTOWN AND NORTHEASTERN SOUTH DAKOTA. THE NURSING HOME OPERATION EXPERIENCED AN OCCUPANCY RATE OF 93.5% FOR THE YEAR (AVERAGE CENSUS OF 151.5 BASED ON 162 LICENSED BEDS). 60 OF THE FACILITY'S 162 BEDS ARE DEVOTED TO THE CARE OF RESIDENTS WITH ALZHEIMER'S DISEASE OR OTHER DEMENTIAS. THE PAYER MIX FOR THE YEAR INCLUDED 53% MEDICAID, 38% PRIVATE PAY, 7% MEDICARE, AND 2% MANAGED CARE.
