The Organizations owns and operates two commercial office buildings as community service centers and leases space to unaffiliated organizations at below market rates in order to further the exempt purposes of these organizations Meeting facilities are also provided and available for use by any nonprofit organization serving the community

The Organization is leading an initiative called Read2Succeed that is focused on improving the quality of early childhood education and grade level reading in Bibb and Baldwin Counties The initiative is a collaboration of over 30 nonprofits, for profit, and governmental entities A state grant from the Department of Early Care and Learning was secured to fund implementation of the Great Start Georgia framework Specific strategies in this area include a First Steps coordinator who is screening parents with children under the age of five in the two counties, and implementing Parents as Teachers, a national evidenced based program that involves parent educators working with families in their homes over a multi-year time frame, teaching parents skills that will advance their child's development and prepare them to be successful in school Read2Succeed also includes a partnership with the Bibb County School System focused on improving 3rd grade reading outcomes A challenge grant from a local foundation has allowed expansion of this program to 10 elementary schools Each school has a Communities in Schools Site Coordinator, and an active volunteer tutoring program for 1st through 3rd grade students
