These affiliated 501(c)(3) organizations provide for college scholarships; assistance to hospitalized, disabled, and deployed veterans and their families; in home physical therapy for disabled children; summer camp for at risk youth; and the maintenance of National Veterans Memorials.

Education in responsible conduct for area youth through afterschool programs for elementary students, and the Sebring Elks Scholarship at South Florida State College. Lodge participates in the Elks National Drug Awareness Program, distributing coloring books and other drug awareness materials at the schools and as part of the community's annual Christmas Parade. We sponsor a boys youth baseball team, a girls softball team and donate to the high school choir. The Lodge works with Big Brothers Big Sisters to send participants from their program to summer camp each year. Each year Sebring Elks partners with Highlands Little Theatre to provide a summer youth theater institute.

4c (Code:) (Expenses \$ including grants of \$) (Revenue \$)

Service to the community through donations to Sebring Fire Department and Breast Cancer Awareness. Sebring Elks donates the use of its entire facility to Highlands County Board of Elections as the polling place for Precinct 7. Lodge members donate monetarily or give food and more for needy families at Christmas and Thanksgiving. We are a major contributor to Children's Services Foundation - Safe House, a shelter for victims of domestic violence. Elks veteran support program: Members of the Lodge visit eight different nursing homes every month, providing recreational and social opportunities, personal supplies, and companionship to veterans in long term care. Sebring Elks is a sponsor of ARC Special Stars, offering sports and recreational activities to children and adults with mental and physical disabilities. The Lodge partnered with Heartland Food Bank to provide weekend meals to 100 elementary students in need.
