United Way of South Mississippi worked to develop long-term solutions to address school readiness and reading on grade level by the end of the 3rd grade Research shows that students who fail to master reading by the end of third grade are four times as likely to leave school without a diploma as proficient readers Our goal is to invest in our most critical resource - our children and their families - in order to create a brighter future for South Mississippi Our education initiatives helped children enter kindergarten more likely to succeed by working with parents and childcare providers to assess and support social and emotional growth We also distributed 20,000 books through Dolly Parton's Imagination Library and trained a team of volunteers in developmental assets by sponsoring a United Way Readers program
