IN FOREIGN COUNTRIES, MR CARMICAL DISCUSSES THE NEEDS OF THOSE INQUIRING WITH LOCAL CHURCH LEADERS OR THE LOCAL MISSIONARY HE THEN TRIES TO SPEAK PERSONALLY WITH THOSE IN NEED, EITHER DIRECTLY OR THROUGH AN INTERPRETER THE DECISION TO GIVE ASSISTANCE IS MADE ACCORDING TO THE SAME CRITERIA LISTED ABOVE FOR THE USA WHEREVER POSSIBLE FUNDS ARE USED TO BUY FOOD OR CLOTHES OR OTHER ITEMS DIRECTLY OR THOSE FUNDS ARE LEFT WITH A RESPONSIBLE PARTY FOR DISBURSEMENT
