Fundraising efforts for the New Hospital Building Campaign resulted in pledged and/or received gifts in the amount of approximately \$41,432. This included monthly pledge payments. The campaign has reached its goal of \$2,000,000, and we are no longer accepting new pledges, but pledge payments are expected through calendar year 2017. Fundraising efforts for the Mission Fund campaign resulted in received gifts in the amount of approximately \$92,696. The Foundation's Festival of Trees Gala raised approximately \$51,700 for the Foundation's Mission Fund in FY'16. The Foundation's Playing for Fundsies Golf Tournament raised approximately \$17,000 for the Foundation's Mission Fund in FY'16. The Mission Fund campaign has since ended, and we are re-focusing our efforts on our Permanent Endowment Fund.
