The Arizona Foundation for Women (AFW) serves as the leading voice for women in Arizona and as a key resource for nonprofit, business and governmental leaders. AFW has provided funding through hundreds of grants to Arizona's programmatic community since our founding in 1995 with the help of foundations, businesses and individuals. No grants were made in the short period for which this tax return is filed, however grants made in September 2015, were still impacting the community during this period. There were nineteen (19) women-focused organizations around the state that helped 6,986 women and their children receive services concerning their safety, health and economic empowerment.

AFW publishes the Report on the Status of Arizona Women and serves as a non-partisan resource by providing reputable data for public policy and community decision-makers. AFW serves as an incubator for new and innovative programs. Though AFW raises awareness through an annual luncheon event for 600 people designed to raise awareness about key issues affecting women and children in Arizona, no luncheon was held during this short period.
