



The organization maintains an irrigation system supplying 235 households and the Leavenworth National Fish Hatchery. Spring cleaning of all equipment, valves and canals is provided. Daily maintenance is provided to the system from May 1st to October by ditchwalkers as well as problem resolution aid to the landowners. Funds are being accumulated to replace 100 year old system laterals.
