LEGAL AID PROVIDES CIVIL LEGAL SERVICES TO THE POOR IN AREAS SUCH AS DOMESTIC VIOLENCE, HOUSING, INCOME MAINTENANCE AND CONSUMER-RELATED ISSUES. APPROXIMATELY 300 VOLUNTEERS ASSIST IN THE CAMPAIGN'S ACTIVITIES.

THE CAMPAIGN EDUCATES THE COMMUNITY AT EVENTS, SEMINARS HELD AT LAW FIRMS AND BAR ASSOCIATION MEETINGS, AND THROUGH NEWSLETTERS AND PUBLICATIONS. THE FOCUS IS ON OREGON'S CIVIL JUSTICE GAP.

OTHER FUNDING INITIATIVES - THE CAMPAIGN SEEKS TO EXPAND RESOURCES FOR LEGAL AID PROGRAMS THROUGH FOUNDATION SUPPORT AND STATE AND FEDERAL FUNDING. THE CAMPAIGN REACHES OUT TO FOUNDATIONS FOR GRANT FUNDING AND ASSISTS WITH GRASSROOTS SUPPORT FOR STATE AND FEDERAL FUNDING.
