This is related to the standards for "Satisfactory Academic Progress," as defined in the IBS catalogue. Funds are distributed at the end of semester, so as to avoid students receiving funds and then discontinuing their studies. By issuing funds at the end of each semester, students are then better able to pay tuition for the following term. Scholarship applications are reviewed by the Scholarship Committee (Dean, Assistant Dean of Academic Affairs, and Director of the Center for Contemporary Shin Buddhist Studies), with attention to both student goals and progress, and donors' intent. While some scholarship endowments make funds available for any IBS students, a few others specifically designate "ministerial candidates," a status determined by the office of the Bishop, Buddhist Churches of America.
