CNPS Plant Science Division had a remarkably successful year. Our Rare Plant scientists expanded ambitious projects, including Rare Plant Seed Rescue (preserving seeds from all California rare plants) and De-extinction Project (re-discovering/resurrecting extinct plant species). Rare Plant Treasure Hunt volunteers mapped our rare plants (2,500 populations mapped so far, 1/3 new discoveries). CNPS Vegetation scientists dramatically advanced our scientific knowledge, mapping special plant communities, and training scores of early-career scientists in the tools they need to help understand and save this remarkable land. Conservation staff successfully advocated for protecting our deserts and reforming forestry.

CNPS Chapters tirelessly work to celebrate and save California's plants and places, key to our inspiring success. Our 35 Chapters across California and Baja delivered 100s of free public events to tens of thousands of Californians. We helped schools grow native plant gardens, provided curricula, and in various ways educated and supported students. In this time of historic drought, CNPS Chapters were the go-to for Californians seeking to convert their water-wasting lawns to pollinator-friendly, chemical-free sanctuaries. CNPS staff supported chapter volunteers with coordination, information, and the benefits of being a single, united, non-profit organization. The result is 95,000 hrs/yr of skilled volunteer time applied to providing important solutions to solving our most important challenges.

The Education Program provided learning experiences for students of all ages. We happily awarded student research scholarships, and delivered key training workshops in a range of skills. To ensure science is applied responsibly, we partnered to launch a Certification for Consultants designed by regulators and academics; it will improve planning, reduce conflicts, and support qualified professionals and planners. We provided unique educational materials to teachers, chapter volunteers, and others, and saw our elementary school nature journaling curriculum applied to engage our next generation by teachers throughout the state. We gifted special care packages of botanical books, posters, and other resources to every library in Kern, Nevada, and Placer Counties, ensuring that citizens, community college students, and high schoolers can discover their remarkable flora and the magic of their own local flowers.
