Accordingly, no provision for Federal or state income taxes has been presented in the accompanying financial statements . Furthermore, the Federation is exempt from filing State of New Jersey information tax returns, and as such, does not file . The Federation adheres to FASB ASC Topic 740, Income Taxes, which provides guidance and clarification on accounting for uncertainty in income taxes recognized in the Federation's financial statements . The guidance prescribes a recognition threshold and measurement attribute for the financial statement recognition and measurement of a tax position taken or expected to be taken in a tax return, and also provides guidance on de-recognition, classification, interest and penalties, disclosure and transition . For the year ended April 30, 2015, the Federation has no material uncertain tax positions to be accounted for in the financial statements . The Federation files information tax returns in the United States Federal jurisdiction . The Federation is no longer subject to tax examinations for United States Federal informational tax returns before fiscal year ended April 30, 2013 .
