The Northern Forest Center advocates for the Northern Forest region and helps its communities benefit from forest-based economic and conservation initiatives.

The Center's Forest Economy programs are creating new economic opportunity and community vitality from the sustainable use of the forest, including:
1. Modern Wood Heating: In FY16, the Center provided incentives for 25 modern wood pellet boiler installations in Maine, Vermont and New York, generating \$451,000 of positive impact for the local and regional economy. Since inception, this program has generated \$3.9 million in positive economic benefit for the region and contributed to a 5,500-ton net reduction in carbon dioxide emissions. Through Windham Wood Heat, the Center helped install 2 large-scale wood pellet boiler systems in schools and public buildings. The Center also advocated for public

Regional Strategy & Capacity Building:
1. The Center provides regional leadership on rural policy and economic strategy, and builds and supports collaborative projects that deliver benefits to communities across the 4-state Northern Forest. In FY16, the Center developed a regional investment strategy to guide the Northern Border Regional Commission's programs and investments for the next five years. Center staff conducted more than 200 interviews to identify local priorities from public, private, and not-for-profit stakeholders and used these to design strategies for the Commission that capitalize on regional assets to grow and retain wealth in the region. The Center advocated for the needs of the Northern Forest's

Community Forest Program:
- The Center helps communities purchase and manage forests that generate economic and community benefits while conserving the forest base in perpetuity. Center staff provided technical assistance to help the community organize Forest Committee, create a governance structure, and develop a forest stewardship plan. The Community Forest will provide the town with income through sustainable timber harvesting, recreational opportunities for hiking, hunting, fishing and enjoying the outdoors. The project also protects important wildlife habitat in New Hampshire's

In FY16, the Center also advanced woodworker training by assisting with training and skills evaluations at wood products companies in the region, enabling 132 employees and students to earn certification on a variety of skills and manufacturing tools.

The Center supported visionary projects that sustained and created forest-based jobs while at the same time providing a range of community and environmental benefits, through use of the New Markets Tax Credit financing program. The Center facilitated a tax credit financing to support the Appalachian Mountain Club's Maine Woods Initiative in the Moosehead Lake - Katahdin Iron Works area. In addition to creating direct jobs during building and trail construction and through the ongoing operation of this popular destination, the tax financing resulted in significant investments in the region's tourism infrastructure, including the Tourism Innovation Program (see 4.a.3 above), trail building and more. The Center is working with other wood products companies and forest land owners to help facilitate this innovative financing. Through five project financings to date, the Center has facilitated \$80 million of investment into the region.

3. The Center strengthens more than a dozen collaborative networks across the region by providing backbone organizational support to advance the common goals of stakeholders. In November, in partnership with the New Hampshire Charitable Foundation, the Center convened more than 120 regional leaders for the Northern Forest Symposium, which engaged participants in building relationships and identifying opportunities to strengthen the region's communities and economies.
