THE MONTHLY AMOUNTS VARY PER INDIVIDUAL AND NEED AND ARE REVIEWED EVERY SIX MONTHS BY THE COMMITTEE TO MAKE SURE MORE MONEY IS NOT NEEDED OR THAT LIFESTYLES HAVE CHANGED. PRESENTLY THERE ARE 39 PEOPLE GETTING MONTHLY ASSISTANCE BUT WE HAVE PROVIDED EMERGENCY ASSISTANCE TO AN ADDITIONAL 34 RECIPIENTS. THE MONEY THAT IS COLLECTED FROM THESE FUNDS COMES FROM OUR CHAPTER DONATIONS ALONG WITH 3 BAZAARS THROUGHOUT EACH FISCAL YEAR TO RAISE MONEY FOR OUR RECIPIENTS.
