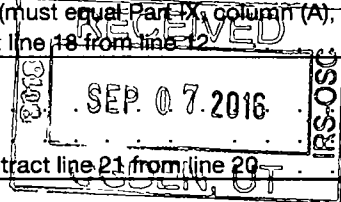

In FY 2015 PCs for People collected nearly 14,000 computers and laptops. Nearly 10,000 of these computers were refurbished and distributed to low-income families and individuals. PCs for People also supported the computers distributed with a 90-day warranty and offered discounted repairs after the warranty period. Repairs were \$25 and any parts needed were free. In FY 2015 over 2,000 repairs were completed at an average cost of \$24 per repair.
