CONSUMERS, CUSTOMERS, AND OTHERS WISH THIS TO BE DEFINED AND PROJECTS TO ASSIST IN THE OVERVIEW OF THE INDUSTRY'S SUSTAINABILITY INDEX ARE NECESSARY TO ANSWER CONSUMERS AND CUSTOMERS' QUESTIONS.
