Advancing AK by uniting practitioners around the world through country or regional chapters with bylaws in agreement with those set by the International Council (IC). The IC is composed of an executive council, representatives of 14 worldwide chapters and a rep from each board: the IBE, which holds exams to certify teachers; the IEC, which oversees the universal teaching syllabus used; the IBORS, which standardizes techniques & protocols and overseas formal research. An IC meeting with congress is held annually.

In the year 2015, our annual IC meeting and congress was held in Seoul Korea and hosted by the the ICAK chapter there. The IC meeting was held on the first day, along with meetings of the various boards listed above and the AK proficiency and teacher certification exams, overseen by the IBE. A congress was held on days 2,3&4 with speakers from around the world presenting papers on AK related topics. The costs incurred by the Korean chapter to host the members of the IC were covered by funds wired from our bank in the amount of 3,650 USD. Other expenses include honorariums of (10x150=1,500 USD) to those IC members attending, (see part IX, line 19c) and \$8,001 for IC executives attending and their work on behalf of the ICAK throughout the year, see part VIIa. The IC receives no income from the meeting as the host chapter is responsible for organising and running the congress. The IBE incurred expenses (exam room booking and examiner honorariums etc.) to the amount of \$10,711 of \$12,349 (see part IX, line 19) and received income from fees paid to sit for exams of \$4,051 (see part VIII, line 2a). The IBE has a treasurer and maintains separate bank and PayPal accounts, submitting to the IC treasurer, an annual financial report which is included in parts VIII and IX. Other IBE expenses include: \$422, administration; \$456, website; \$155 diploma calligraphy.

In 2015, this fund operated by the IEC (Internation Education Council) for a second year, is included in the ICAK filing. New members or certified teachers in AK are charged \$150 to maintain their teacher status for a 3 year period. The purpose of this fund is to provide revenue for future IEC initiatives. The IEC has functioned, strictly by volunteer over the years and work on behalf of the IEC has been insufficient to meet its expanding mandate. This fund is to cover administration costs and honorariums to work done on behalf of the IEC.

Initially, to determine proficiency in AK by all its members and later, for those members so inclined and who meet the requirements, to become certified teachers. The importance of this examination process is at first, to promote a high level of skill and understanding of AK technique amongst the membership but to accomplish this a second, higher level of examination is used to produce diplomates in AK, designated by the post-nominal letters, DIBAK. Only DIBAK's can become certified teachers. At an arms length from the IC is the IBE, a board within the ICAK, which design exam questions, organize exams at annual meetings (IC and chapter meetings with sufficient numbers to meet costs) and proctor and grade these exams. The IEC, another board within the ICAK, oversees the re/certification of teachers and the standardization of the ICAK teaching syllabus. Both the IBE and IEC maintain their own treasury and submit reports included in this filing.

IBORS, a third board within the ICAK, oversees research and standardization of AK technique. For 2015, no funds were allocated for research.
Form 990, part VI, line 11b: The ICAK treasurer, who completes this filing, distributes a PDF copy to the IC executive for review and comment prior to mailing to the IRS.

Form 990, part VI, line 12c: If, on the occasion of selecting or engaging a vendor or service provider, anyone in attendance where there could be a perceived conflict of interest, would be asked to recuse themselves from the discussion. Annually, if on the occasion of any board member acknowledging a possibility of conflict or another member being aware of such, the conflict of interest policy is reviewed at it pertains to the immediate circumstances. There is a Judicial/Conflict Resolution Committee (JRC) in place, should such a need arise.

Form 990, part VI, line 15a,b: The IC reviews compensations for all officers, ensuring they are compatible to like positions in comparable orgs. The IC then approves the compensations, with any changes deemed appropriate, reasonable and fiscally responsible.

Form 990, part VI, line 19: The ICAK will provide in a timely manner upon request, copies of all governing documents, including conflict of interest and financial statements, whether in writing or person when contacted at the addresses in form 990, top of page 1 or part VI, line 20.

Form 990, part VI, line 9a: The contact information of the officers and trustees (chapter and board reps) will be provided upon request at the above addresses.

Form 990, part IV, line 21: The ICAK is an international organization of health professionals and receives dues from its members within and without the US. The ICAK holds an annual meeting with scientific congress for its members. It is hosted by different chapters each year who have submitted a proposal with budget for IC review and vote, at least 2 years prior to proposed date. In this current year a very successful meeting was held in Seoul, South Korea and funds to assist ICAK-Korea host this event are reported in schedule F.
