 ENSURING ACCESS to quality higher education to students from economically challenged families 31% of Arcadia's 598 new entering Fall 2015 freshmen would be the first in their families to graduate from a college, 38% of them received need-based federal Pell Grants (awarded by federal formula to students from low-income families), 2% were covered by PA Act 101 (for those whose cultural, economic, and educational disadvantages might impede their ability to succeed in college) In addition to these state and federal programs, Arcadia provides financial assistance in the form of grants and scholarships to 99% of full time undergraduate students Among the entire Arcadia undergraduate population of 2,640 students enrolled during the fall 2015, 32% were receiving Pell Grants, 27% would be the first in their families to graduate from college, 2% were covered by Act 101, and 90% received University-financed financial assistance, 66% received Work Study support Arcadia also provides academic support through the Gateway to Success program, which includes Act 101 services for PA residents who qualify at 200% of the poverty level and provides personal attention and resources throughout the academic year to help them succeed

 Ensuring a GLOBAL OPPORTUNITY for as many students as possible Arcadia is distinct in that all of our students--undergraduate and graduate alike--engage in integrative, real-world learning opportunities such as internships, evidence-based research, service learning, interdisciplinary study, problem-based learning, and co-curricular learning experiences that expand beyond the traditional classroom 74% of the undergraduate class graduating in May 2016 had used their passports while they were students at Arcadia In 2016, 340 freshmen and 50 transfer students studied in 15 locales around the globe during spring break, as part of an academic (2-credit) program 61 freshmen studied abroad for a semester during their first year, in either England or Scotland, and 552 other Arcadia students studied abroad during 2015-16 The University has adopted a "Global Connectors" undergraduate curriculum that ensures immersion with global issues through study abroad or a domestic global experience Graduate programs also include either curricular or co-curricular (e.g., pro bono service) requirements and/or opportunities for our students In addition to more than 4,000 students on its U.S. campuses, Arcadia provides educational opportunities at its centers and programs around the world to more than 2,500 students annually from other colleges and universities through The College of Global Studies at Arcadia University

 We believe that living in close proximity to people from different backgrounds is a critically important way for students to learn important life skills, and we treat residential life as an important opportunity for learning Our desire is to ensure that students' living arrangements support and enhance their educational work and goals While our primary goal is to provide safe living environments conducive to study and academic success, we encourage and support the development of the following core competencies in our students: diversity and inclusion, global perspectives, civic engagement, citizenship, self-advocacy, problem-solving, respect for others, and the development of identity, purpose, and integrity Within the residence halls and apartments, an engaged team of professional and paraprofessional staff use the physical structure of the living environment as a tool to maximize learning moments and challenge students to develop and apply these competencies Arcadia provides first-year students (freshmen) the option to select to live in an enhanced community which adds a more intentional, focused social opportunity based on the community's theme
