DEGREES OFFERED INCLUDE MASTER OF DIVINITY (M DIV), MASTER OF ARTS IN THEOLOGY AND MINISTRY (M A T M), MASTER OF THEOLOGICAL STUDIES (M T S), MASTER OF THEOLOGY (TH M), DOCTOR OF MINISTRY (D MIN), DOCTOR OF PHILOSOPHY (PH D), AS WELL AS COLLABORATIVE DEGREES WITH THE NEELEY SCHOOL OF BUSINESS AT TCU (M DIV / M B A, M A T M / M B A AND M T S / M B A) AND THE TCU DEPARTMENT OF SOCIAL WORK (M DIV / M S W AND M T S / M S W). BRITE ALSO OFFERS SEVEN CERTIFICATE PROGRAMS FOR NON-DEGREE SEEKING STUDENTS. BRITE HAS INTRODUCED SESSIONS ON DEVELOPING SKILLS FOR EFFECTIVE GRADUATE-LEVEL WRITING AND CONTINUES TO ENHANCE ITS ONGOING SUPPORT FOR WRITING ASSISTANCE THROUGH THE WILLIAM L. ADAMS CENTER FOR WRITING AT TCU. ESSENTIAL TO AND IN SUPPORT OF THE DEGREE PROGRAMS AND FACULTY RESEARCH IS OUR LIBRARY WITH OVER 158,000 PRINTED VOLUMES AND 70,000 BOUND PERIODICALS, PLUS ADDITIONAL E-BOOKS, JOURNALS AND RELATED INDICES.
