WLP provides information about Agent Orange/Dioxin to US Veterans, their families, students and the general public through the website <http://www.agentorangerecord.com>, providing information to journalists and documentary film makers, and public speaking events.

Humanitarian Assistance Program for People with Disabilities: The program focuses on poor families in Vietnam with one or more children with with severe and/or multiple disabilities. It provides direct assistance to the families and/or children to provide livelihood support, improve housing conditions, medical care and/or adaptive equipment, support education and vocational training expenses, and provides support and training to parents who are caring for severely disabled children.

The project provided support to 30 families in Quang Nam Province Vietnam to improve their livelihoods and built new houses for two families. It supported the costs of one young girl to receive prosthetic legs and pay for her school expenses in Cu Chi District, Ho Chi Minh City, Vietnam. It provided support for school expenses for 9 children with disabilities in Quang Nam province. It also supported the operating costs of the Peace Village in Ho Chi Minh City for disabled children and the Bien Hoa Center for Disabled Children in Bien Hoa, Vietnam. It also provided training to 10 Red Cross volunteers on how to work with children with disabilities and provide advice and support to parents of children with disabilities.

4b (Code:) (Expenses \$ 43,908 including grants of \$) (Revenue \$)

Support to People with Disabilities in Laos: The project identifies and provides health care and educational support to children and youths with disabilities along the former Ho Chi Minh Trail area of Laos. It also provides livelihood support to families caring for children with disabilities. The project also investigates areas of Laos that may have potential dioxin contamination from the use of military herbicides in Laos during the American war.

The project surveyed 25 villages in 6 districts of Salavan and Savannakhet provinces of Laos along the former Ho Chi Minh Trail area. It also raised awareness in villages and district government offices about the potential health and environmental impacts of the use of dioxin contaminated herbicides during the American war in Laos, the types of birth defects and disabilities the project could help address. 73 children and adults under the age of 55 with congenital malformations and birth defects were identified. 26 received surgeries, prosthetic services, adaptive equipment or examinations by medical specialists. Four youths with disabilities receive support to undertake vocational education programs or continue their primary education.

4c (Code:) (Expenses \$ 23,235 including grants of \$ 10,000) (Revenue \$)

Bringing Health Care Home: An 8 month pilot program to identify and address health issues among children with disabilities, to teach parents proper and safe care-giving skills and to help CWDs learn self-care, communication and socialization skills to be more independent and integrated into the community.

40 Red Cross staff and volunteers conducted home health care visits to 50 children and youth with disabilities in Quang Nam, Vietnam for 6 months. The volunteers worked with each of the parents to provide care-giving training, worked with the children with disabilities to improve their self-care, socialization and communication skills. The project also provided direct support to the 50 children in the form of adaptive equipment, nutrition, support for school expenses, and/or bikes to travel to school.
