THE CENTER CURRENTLY SERVES APPROXIMATELY 80 CHILDREN ON A FULL-TIME OR LIMITED BASIS, PLUS AN ADDITIONAL 20-22 FOR SUMMER PROGRAMS. SOME DIRECT SERVICES ARE PROVIDED TO CHILDREN IN THEIR HOMES AND OTHER SETTINGS ALONG WITH CONSULTATIVE SERVICES TO PARENTS AND OTHER CARE GIVERS.
