EDUCATIONAL OPPORTUNITIES ARE A CORNERSTONE OF CWC. PROGRAMMING IN FINE ARTS, LANGUAGE ARTS, AND SOCIAL SCIENCES IS OFFERED THROUGHOUT THE YEAR, VIA 33 EDUCATIONAL GROUPS. EDUCATIONAL GROUPS ARE DIVIDED INTO TWO CATEGORIES BASED ON THE FORMAT OF THE PROGRAMMING. GROUPS THAT TYPICALLY HAVE A FORMAL PRESENTATION, LECTURE, OR SPEAKER ARE CALLED PROGRAMS/LECTURES. THESE INCLUDE ANTIQUES, ART, BIBLE, BOOK REVIEW, CIVICS, DRAMA, FILM, GARDEN, GOURMET, GREEK, HISTORY, LUNCH-N-LEARN, MUSIC, SCIENCE, TRAVEL, AND WOMEN'S HEALTH AND WELLNESS. THE REMAINING GROUPS, WHERE MEMBERS USUALLY PARTICIPATE IN THE PROGRAM ITSELF, ARE CALLED CLASSES. CLASSES INCLUDE ARTS AND CRAFTS, BIBLICAL LITERATURE, BOOK DISCUSSION, BRIDGE, CHORAL, COLLECTOR'S CORNER, CREATIVE WRITERS, DRAWING, FINANCE, GREAT BOOKS, NEEDLEWORK, PAINTING, PHOTOGRAPHY, PLAYERS, TECHNOLOGY, TAI CHI, AND YOGA. ALL EDUCATIONAL GROUPS SCHEDULE ACTIVITIES FROM SEPTEMBER THROUGH MAY, OFFERING MORE THAN FOUR HUNDRED EDUCATIONAL OPPORTUNITIES PER YEAR. PROGRAMS/LECTURES TYPICALLY MEET BETWEEN THREE AND NINE TIMES PER YEAR, AND CLASSES MEET AS OFTEN AS WEEKLY. CHAIRMEN AND VICE-CHAIRMEN, SELECTED BY EACH GROUP, PLAN PROGRAMS AND OBTAIN SPEAKERS OR INSTRUCTORS, AS NEEDED. EDUCATIONAL OPPORTUNITIES ARE OPEN TO ALL CWC MEMBERS, CONSISTENT WITH THE OBJECTIVE OF WELCOMING MEMBER PARTICIPATION AND ATTENDANCE AT ALL EDUCATIONAL PROGRAMS AND STUDIES. MEMBERS ARE WELCOME TO INVITE GUESTS TO ALL PROGRAMS/LECTURES AND MANY CLASSES. POP-UP PROGRAMS AND CLASSES ARE ADDED THROUGHOUT THE YEAR BY THE EDUCATION COORDINATION COMMITTEE. THESE ARE PROGRAMS ON A TOPIC THAT ARISES DURING THE YEAR OR SMALL HANDS-ON CLASSES ON SUBJECT MATTER NOT COVERED ELSEWHERE IN THE CWC EDUCATIONAL PROGRAM. THE SUMMER PROGRAM OFFERS A VARIETY OF ACTIVITIES FOR THE EDUCATION AND ENJOYMENT OF MEMBERS DURING JUNE AND JULY.

THE PHILANTHROPY PROGRAM PROVIDES ASSISTANCE TO VARIOUS CHARITIES SELECTED BY CLUB MEMBERS THROUGHOUT CINCINNATI. COMMUNITY IMPACT, A MAJOR COMPONENT OF PHILANTHROPY, DEVELOPS ENJOYABLE AND PRODUCTIVE PROGRAMS THAT ACTIVELY INVOLVE OUR MEMBERS. TEN CHARITABLE AGENCIES WERE SELECTED TO RECEIVE MONETARY DONATIONS. CWC MEMBERS NOMINATED CHARITABLE AGENCIES FROM WHICH THE PHILANTHROPY STEERING COMMITTEE SELECTED TEN TO BE PRESENTED AT THE NOVEMBER GENERAL MEETING. TEN MEMBERS WHO WERE EACH ASSIGNED AN ORGANIZATION VISITED THE ORGANIZATION TO GATHER INFORMATION THAT WAS USED IN A DIGITAL PRESENTATION AND VISUAL DISPLAY ON BEHALF OF HER AGENCY. THE AGENCIES WHO RECEIVED MONETARY DONATIONS FROM THE CINCINNATI WOMAN'S CLUB WERE CARE CENTER ANIMAL BLOOD BANK, CINCINNATI WORKS, THE DRAGONFLY FOUNDATION, FIRST TEE OF GREATER CINCINNATI & NORTHERN KY, MINDPEACE, MUSIC RESOURCE CENTER, NEW LIFE FURNITURE, PROJECT HEALING WATERS, SANTA MARIA COMMUNITY SERVICES, VISIONARIES & VOICES, PRESIDENT'S PROJECT, CINCINNATI COOKS!, AN OUTREACH PROGRAM OF FREESTORE FOODBANK, WAS CHOSEN AS THE PHILANTHROPIC PORTION OF THE 2015-2016 PRESIDENT'S PROJECT. CINCINNATI COOKS! TEACHES NON-WORKING ADULTS THE CULINARY SKILLS THAT MAKE THEM SUCCESSFUL IN JOBS IN LOCAL RESTAURANTS, LEADING TO A MORE SECURE AND SELF-SUFFICIENT FUTURE THANKS TO CWC FUNDRAISING, A COMBINED GIFT (\$40,000 FROM THE CWC AND \$25,000 MATCH), CINCINNATI COOKS! PURCHASED A SPECIALIZED VAN FOR TRANSPORTING MEALS DAILY TO THEIR KIDS CAF LOCATIONS. IN ADDITION, CINCINNATI COOKS! WAS ABLE TO ACQUIRE ESSENTIAL STORAGE EQUIPMENT DESIGNED TO SAFELY MAINTAIN FOOD TEMPERATURE DURING TRANSIT. IN ADDITION TO THE MONETARY DONATIONS THIS YEAR, THERE WERE A NUMBER OF NON-MONETARY DONATIONS AS FOLLOWS: MONTHLY CHARITABLE DONATIONS (GIFT SLEIGH). DURING OCTOBER AND NOVEMBER, MEMBERS DONATED ITEMS TO THE GIFT SLEIGH TO BENEFIT THE LITTLE BROTHERS, FRIENDS OF THE ELDERLY, AN ORGANIZATION THAT IS COMMITTED TO HELPING THE ELDERLY AVOID ISOLATION AND LONELINESS. MEMBERS DONATED VARIOUS ITEMS SUCH AS BEAUTY CARE ITEMS, PAPER GOODS, SOCKS, AND CLEANING SUPPLIES, ALONG WITH TRAVEL-SIZE ITEMS AND GIFT CARDS. THE VALUE OF THESE ITEMS WAS \$324. THE DECEMBER GIFT SLEIGH IS TRADITIONALLY DEVOTED TO GATHERING SOCKS, HATS AND MITTENS FOR CHILDREN. THIS YEAR THE SLEIGH COLLECTED MORE THAN FIVE HUNDRED ITEMS THAT WERE DISTRIBUTED TO THE RESIDENTS OF ONE WAY FARM, THE CLIENTS OF MANNA FOOD PANTRY, AND THE SALVATION ARMY. THE OVER-THE-RHINE AND WALNUT HILLS KITCHENS, WHICH PROVIDE MEALS FOR THE NEEDY, RECEIVED ITEMS WORTH \$150 TO SUPPORT THIS AGENCY AND ITS CLIENTS DURING JANUARY AND FEBRUARY. IN MARCH, APRIL, AND MAY THE COLLECTIONS FOR SAVE THE ANIMALS FOUNDATION WERE VALUED AT \$325. THIS FOUNDATION IS A NON-PROFIT ORGANIZATION FUNDED COMPLETELY BY DONATIONS AND FUNDRAISERS. IT PROVIDES A NO-KILL SHELTER FOR CATS AND DOGS WHO RECEIVE PHYSICAL AND EMOTIONAL CARE UNTIL AN ADOPTIVE HOME IS FOUND. ARTS AND CRAFTS PROJECTS: THE ARTS AND CRAFTS CLASS CREATED FORTY FLAGS, SEVENTY PILLOWCASES, AND MORE THAN TWENTY-FIVE DITTY BAGS TO HOLD TREASURES FOR THE CHILDREN AT FERNSIDE. THIS ORGANIZATION PROVIDES SUPPORT FOR GRIEVING CHILDREN. CLARA GATES IRVING MEMORIAL (KNITTERS). THE CWC KNITTERS CREATED BEAUTIFUL AND UNIQUE SWEATERS, HATS, AND MITTENS. 115 SWEATERS, MANY WITH MATCHING HATS, WERE DISTRIBUTED TO OUR DAILY BREAD, SANTA MARIA COMMUNITY SERVICES, THE SALVATION ARMY, AND YMCA CHRIST CHILD DAY NURSERY. EYEGLASS COLLECTION. THIS YEAR SEVENTY-FOUR PAIRS OF EYEGLASSES WERE CONTRIBUTED TO LENS-CRAFTERS TO BE REFURBISHED AND DISTRIBUTED TO THE VISUALLY IMPAIRED. THE DONATION OF THESE LENSES BY THE CINCINNATI WOMAN'S CLUB PROVIDES THE GIFT OF SIGHT TO MANY WHO ARE UNABLE TO PURCHASE THEIR OWN LENSES. MEDICINE BOTTLES FOR DISASTER RELIEF ORGANIZATIONS. MEMBERS DONATED MANY NON-GLASS CONTAINERS WHICH WERE DELIVERED TO THE MATTHEW 25 MINISTRIES WHERE THEY WERE PREPARED FOR DISTRIBUTING MEDICATIONS HYGIENICALLY TO THOSE IN DISASTER AREAS THROUGHOUT THE WORLD. MEDICATIONS ARE SENT IN BULK FROM THE PHARMACEUTICAL COMPANIES, AND THESE HYGIENIC CONTAINERS PROVIDE A WAY FOR PATIENTS TO TRANSPORT THEIR MEDICATIONS SAFELY. RONALD MCDONALD HOUSE CHARITIES. MEMBERS OF THE CWC COLLECT PULL TABS FROM METAL CANS AND DONATE THEM TO THE RONALD MCDONALD HOUSE. THIS ORGANIZATION THEN SELLS THESE VALUABLE TABS TO A SCRAP METAL DEALER, YIELDING FUNDS TO SUPPORT THE HOUSE'S ADMINISTRATIVE DUTIES AND TUTORING AS WELL AS HELPING WITH THE COST OF BIRTHDAY PARTIES AND HOLIDAY CELEBRATIONS. SALVATION ARMY "DRESS A DOLL" COLLECTION. THE SALVATION ARMY PROVIDED FOURTEEN DOLLS AND FIVE TEDDY BEARS WHICH WERE SKILLFULLY DRESSED IN BEAUTIFUL HAND-MADE OUTFITS BY ELEVEN CWC LADIES. IN ADDITION, TWO OF THE DRESSERS HAD AUCTION DOLLS WITH TEN OR MORE OUTFITS AND NUMEROUS PAIRS OF SHOES, THESE WERE SOLD FOR \$160 AND \$170. THE DOLLS WERE DONATED TO THE SALVATION ARMY TOY SHOP AUXILIARY FOR DISTRIBUTION TO CHILDREN IN THE CINCINNATI AREA. SUMMIT BEHAVIORAL HEALTH CENTER. CWC MEMBERS PREPARED ELEVEN CHRISTMAS BASKETS AND ELEVEN EASTER BASKETS FOR THE RESIDENTS OF THE SUMMIT BEHAVIORAL CENTER. THESE TREATS BROUGHT THE RESIDENTS HAPPINESS AND GREAT ENJOYMENT. CWC CAN DO PROJECTS. CWC CAN DO PROJECTS ACTIVELY INVOLVED MANY MEMBERS IN A VARIETY OF PHILANTHROPIC ENDEAVORS. THE PRACTICE OF PLANNING TWO-HOUR LABOR INTENSIVE SESSIONS FOR HANDS-ON PROJECTS CONTINUED. THE CLUB'S LONG HISTORY OF SERVING AND IMPROVING THE COMMUNITY. ALL VOLUNTEERS ENJOYED THE CAMARADERIE THAT RESULTED FROM WORKING TOGETHER, AND THE SESSIONS PROVIDED NEWER MEMBERS AN OPPORTUNITY TO MEET OTHER MEMBERS OF THE CLUB. EACH SESSION INVOLVED SIX TO TWENTY MEMBERS. ABC SOCCER. MEMBERS GATHERED IN NOVEMBER TO PACK 150 GIFT BAGS FOR THE MEMBERS OF ABC SOCCER TEAMS. THIS EFFORT HELPS YOUNG GIRLS IN THE FOURTH THROUGH SIXTH GRADES PARTICIPATE ON SOCCER TEAMS DURING THEIR AFTERSCHOOL HOURS. GIFT BAGS CONTAINED A TRAVEL BAG FILLED WITH HYGIENIC PRODUCTS AND A NOTE OF ENCOURAGEMENT TO CONTINUE THEIR INVOLVEMENT WITH SOCCER AND ACADEMIC PURSUITS. BLANKET PROJECT. THE COMMITTEE CREATED 175 FLEECE LAP BLANKETS. THIS YEAR VOLUNTEERS CUT LENGTHS AND EDGED THEM DURING THE GATHERING. SOME CLUB MEMBERS WHO COULD NOT ATTEND TOOK BLANKET KITS HOME TO WORK ON THEM. SEVERAL MEMBERS ALSO DONATED GIFTS OF FLEECE YARDAGE TO THIS PROJECT. IN NOVEMBER THE LAP BLANKETS WERE DISTRIBUTED TO EACH CHILD AT ONE WAY FARM, TO SANTA MARIA COMMUNITY SERVICES FOR SENIORS, TO JOSEPH HOME FOR THEIR HOMELESS VETERANS, TO THE VISITING NURSE ASSOCIATION, TO THE EPISCOPAL RETIREMENT HOMES FOR THEIR MEALS ON WHEELS PROGRAM, AND TO THE SALVATION ARMY FOR THEIR SHELTERS FOR WOMEN AND CHILDREN. EVERY CHILD SUCCEEDS. IN DECEMBER A GROUP OF CWC MEMBERS GATHERED TO CREATE EIGHTY-FIVE WORD BOOKS FOR EVERY CHILD SUCCEEDS. THESE HAND-SIZED, FOLD-OVER BOOKLETS FEATURED STARTING SOUNDS, PICTURES, AND WORDS FOR A MOTHER OR CAREGIVER TO "READ" TO HER CHILD. IN ADDITION, THE AGENCY RECEIVED A CONTRIBUTION OF \$300 TO SUPPORT THEIR WORK. EVERY CHILD SUCCEEDS SUPPORTS THE EARLY EDUCATION OF CHILDREN BY PROVIDING EDUCATIONAL MATERIALS AND TRAINING YOUNG MOTHERS TO USE THESE MATERIALS TO STIMULATE THEIR CHILD'S COGNITIVE DEVELOPMENT. FISHER HOUSE. FISHER HOUSE PROVIDES A RESIDENCE FOR SERIOUSLY ILL VETERANS WHO ARE RECEIVING CARE AT THE CINCINNATI VETERANS ADMINISTRATION HOSPITAL. DEDICATED MEMBERS GATHERED IN SEPTEMBER TO CREATE SIXTEEN FALL WREATHS FOR THEIR RESIDENTS. IN ADDITION, WE PACKED ONE HUNDRED WELCOME BAGS THAT INCLUDED PERSONAL LETTERS EXPRESSING OUR APPRECIATION FOR THEIR SERVICE AND WISHING THEM WELL WITH THEIR TREATMENTS. FREESTORE FOODBANK. MEMBERS TRAVELED TO THE FREESTORE FOODBANK TO ASSEMBLE POWER PACKS FOR CHILDREN IN NEED. GLAD HOUSE COOKING. TWO COOK-OFF EVENTS WERE SCHEDULED FOR GLAD HOUSE THIS YEAR. SEVERAL CWC MEMBERS PLANNED, PURCHASED, AND PREPARED FIVE MEALS FOR FORTY-EIGHT GLAD HOUSE CHILDREN AND THEIR FAMILIES WHO ATTEND THE STRENGTHENING FAMILIES PROGRAM. ONE WAY FARM COOKING. MEMBERS GATHERED IN JANUARY AND APRIL TO PREPARE MEALS FOR THE RESIDENTS OF ONE WAY FARM. AT EACH EVENT MEMBERS PREPARED SIX MEALS THAT EQUATED TWENTY-FOUR TOTAL SERVINGS. PROJECT CARE. MEMBERS PACKAGED BOXES FOR DELIVERY TO A UNIT OF AIR FORCE PERSONNEL DEPLOYED AT AN OUTPOST IN THE MIDDLE EAST IN AL UDEID AB, QATAR. THIRTY-FOUR BOXES WERE SHIPPED FILLED WITH A VARIETY OF TREATS AND SNACK FOODS, ALONG WITH BOOKS. PERSONAL LETTERS ACCOMPANIED EVERY BOX BRINGING NEWS OF HOME AND EXPRESSING GRATITUDE FOR EACH INDIVIDUAL'S SERVICE. PROJECT HEALING WATERS. A SMALL GROUP OF CWC VOLUNTEERS PREPARED, PACKAGED, AND DELIVERED TWENTY-FOUR LUNCHEONS TO THE VETERANS WHILE THEY WERE FISHING AT WINTON WOODS. ST. PAUL'S VILLAGE. FOUR MEMBERS VISITED THE CENTER WITH CHRISTMAS WREATHS AND AN ASSORTMENT OF ITEMS WITH WHICH TO DECORATE THEM. SIXTEEN WREATHS WERE COMPLETED.

THE CLUB AWARDED SCHOLARSHIPS TO 22 STUDENTS AND AN ADDITIONAL SCHOLARSHIP WAS GIVEN TO A STUDENT OF THE COLLEGE-CONSERVATORY OF MUSIC. SCHOLARSHIPS AWARDED TOTALED \$43,380. THE ANNUAL SCHOLARSHIP PROGRAM WAS HELD ON NOVEMBER 20, 2015. MEMBERS WELCOMED THE SCHOLARS AND GUESTS AND DELIVERED A BRIEF HISTORY OF THE SCHOLARSHIP PROGRAM. THE STUDENTS WHO ATTENDED SHARED MULTIMEDIA PRESENTATIONS THAT FOCUSED ON THEIR GOALS AND ACADEMIC OR EXTRACURRICULAR ACTIVITIES. FOLLOWING THE PRESENTATION, SCHOLARS, UC GUESTS, AND MEMBERS ENJOYED A LUNCHEON. IN ADDITION TO THE NOVEMBER PROGRAM, STUDENTS HAVE A CWC MEMBER WHO SERVES AS A MENTOR THROUGHOUT THE YEARS OF THE SCHOLARSHIP. STUDENTS ALSO PARTICIPATED IN AN AFTERNOON TEA AT CWC IN OCTOBER AND MET WITH MEMBERS OF THE PHILANTHROPY COMMITTEE AND THEIR MENTORS.
