During the period beginning May 1, 2015 and ending April 30, 2015, Hogar Infantil, Inc. provided most of the financial support needed for the operation of Casa Hogar La Gloria, AC in Tijuana, Mexico. This support provided a safe home for a total of 38 children, aged two months to fifteen years old over the course of the year. We helped pay the salaries and benefits of nineteen full-time employees who care for the children 24 hours a day, 7 days a week. Our funding also covered the cost of special workshops for the children and staff development for the employees. Two of the children received physical therapy, and all children received age-appropriate psychological therapy. Infants and toddlers received specialized early childhood stimulation therapy. Fourteen of the children were enrolled in summer day camp, and also participated in a group camping vacation near the beach south of Ensenada. All school-age children were enrolled in a full time course of study in one of three schools. Some of the older children continue to participate in extra-curricular marital arts training. All meals, clothing, housing, and personal costs for the children were covered. We paid expenses for transportation, including vehicle maintenance and repair, utilities including gas, water and electricity, building maintenance and repair, and all state and local taxes associated with the facility. Special projects during the course of the year included structural seismic retrofitting of the foundation under the infant's dormitory, significant updating of roofing and gas lines, the construction of a private bedroom for one of the adolescent children inside the girl's dormitory, and the creation of 'soft spaces' for study and recreation inside boys' and girls' dorms. We continued to engage the services of an outside consultant to assist in staff development, and to work with legal counsel toward obtaining desired legal status for the operation and property "
