4a	(Code) (Expenses \$ 217,322 including grants of \$ 182,141) (Revenue \$)	Educational and leadership programming Through activities that encompass the individual chapter, the fraternity/sorority community, the university community, and society in general The Sigma Kappa Foundation provides funding for programs and resources designed to promote personal and leadership development Grants are made pursuant to appropriate grant documentation No grants or allocations are/or include foreign grants Sigma Kappa Educational GrantsThe grant for the leadership consultant program is used to conduct the individual and group counseling of chapter members and the training of individuals to do such counseling Group development includes workshops and lectures on leadership and educational development, assertiveness training, achievement of high scholastic attainment, citizenship, career development, alcohol and drug abuse prevention and advanced leadership training for selected individuals Individual counseling includes one-on-one sessions with selected undergraduate chapter members of the Sorority regarding leadership opportunities and scholarship and study techniques, and in addition each consultant should be available to advise any chapter member seeking individualized counseling regarding educational opportunities and problems Successes of this program during the granting year include - Focused chapter program - At times, this is the chapter's only hope of remaining an open and active chapter At other times, chapters are put on the focused chapter program to prevent them from getting to the point of being on their last leg A leadership consultant visits the chapter monthly and provides continued long distance support and guidance that the chapter and alumnae volunteers would not get otherwise - Good to great program - This new program, created in 2013, provides support to chapters who are functioning well on their campus and in Sigma Kappa The leadership consultants who work with these chapters challenge them to improve in all areas of collegiate management and recruitment The goal is to take a chapter who ranges from average to a little above average to top-tier in Sigma Kappa and on their campus - New chapter program - The organization bases a leadership consultant with each colony/new chapter for up to their first three years of existence The goal of this program is to provide new chapters the guidance needed to become a successful, established chapter within Sigma Kappa and on their campus The leadership consultant works very closely with each member of the new chapter to foster a strong connection to the organization and its values, leading them to a lifelong commitment to Sigma Kappa - Initiation rate of the national organization - We had a 98.7% Initiation rate in the 2014-2015 academic year, up 7 percent from 2013-2014 While this is not a direct result of the LC program, it is a component of the effectiveness of it A grant was made to support the educational portion of the Director of Educational Programs position for Sigma Kappa Sorority This position coordinates the educational programming and workshops that provide leadership, personal and professional development for women A final grant was given to the sorority to conduct educational and leadership activities at the Sorority's Regional Leadership Conferences (RLCs) Such activities include the conduct of general and track breakout sessions in the areas of leadership development, bystander behavior, chapter motivation and other chapter education related topics for chapter members and advisors This experience aims to provide - Personal development of collegiate leaders and advisors- Leadership training for all women- Life skill developmentAs a result of the RLCs, more than three times the women receive leadership development training than under the former structure The participants report feeling more comfortable addressing complex issues within their chapter and among their members after attending the RLC The program continues to be improved annually based on feedback from participants Finally, the Sorority requested funding to pilot sexual assault awareness programming Sigma Kappa partnered with Aaron Boe, the founder of Prevention Culture, which specializes in non-stranger sexual assault and relational violence prevention, healthy relationships, and bystander intervention Boe is a leading consultant in the fraternity/sorority community on preventing sexual misconduct and partner aggression As a curriculum developer, trainer and speaker, he takes a positive approach to addressing serious situations Boe created for Sigma Kappa a peer-led sexual assault workshop that was piloted with identified chapters in fall 2015 and launched to all chapters in spring 2016 This sexual assault education workshop aims to equip collegians with the tools necessary to create safe and supportive chapter cultures It covers topics including healthy standards for personal relationships, misconceptions about non-stranger sexual assault, intervention techniques for complicated social situations, and ways to support a survivor Sigma Kappa is working with Boe to customize the program and implementation options to meet the distinct needs of our collegiate chapters Boe provided training for leadership consultants and sorority staff in January 2016 to help equip them to support situations in our collegiate chapters, as well as assist in facilitating the workshop for chapters who request it Lastly, Boe has an e-book that covers topics included in the workshop in a more in-depth way, and is an ideal companion to the workshop Once finished, this e-book will be made available to members to download individually Additional grants to Sigma Kappa chapters and membersAdditional educational and leadership grants (\$12,500) were made to Alpha Delta, Gamma Kappa, Lambda Beta, Theta Phi, Zeta and Zeta Phi chapters to implement philanthropic and service programs in their local communities, 9 grants to individuals to attend the Undergraduate Interfraternity Institute and LeaderShape, national values-based leadership programs (totaling \$7,355)
