Provide post-secondary education leading to a baccalaureate degree. Program service expenditures are made in conjunction with the operation of a liberal arts college spread over 107 acres with approximately 56 educational and support buildings. The College is accredited by the North Central Association of Schools, and had 1,561 full time equivalent students in the undergraduate level with 106 full time equivalent faculty. Bachelor of Arts degrees conferred were 385 during the year, with 10 Master's degrees were conferred. The College had approximately 1,215 resident students in the residence halls.
