Division of Postdoctoral Training -Approved 68 new programs (895 positions), increased size of 64 programs and revised 273 programs for Continuing Approval -Conducted 7 Osteopathic Postdoctoral Training Institution (OPTI) continuing approval site visits -Executed a national education conference for residency program directors and medical educators -Approved 435 ACC-ME PGY1 58 Federal/Military PGY1 and 191 ACC-ME PGY2/Fellowship Training applications. Division of Training Program Review Services -Continued its charge of reviewing all osteopathic training programs.

Membership Services The Department of Membership is responsible for developing and executing initiatives that provide significant financial and volunteer resources to support the AOA's mission by retaining and recruiting 48,219 members. Membership projects build awareness of overall AOA programs that ultimately lead to improved quality of patient care, such as the iLearn Mentor Program, the Clinical Assessment Program, practice management programs for young physicians, and leadership development opportunities and information for students, interns and residents.

Publications The AOA publishes 2 peer-reviewed scientific publications. The Journal of the American Osteopathic Association (JAOA) and the AOA Health Watch. These print and online publications provide continuing medical education (CME) to osteopathic physicians (DO's) and other health care professionals, and they complement the education of osteopathic medical students. Approximately 27,000 primary care DO's receive the print copies and more than 110,000 receive the electronic tables of contents for the JAOA. For AOA Health Watch, about 38,500 primary care DO's and specialists receive the print copies, while 100,000 receive electronic alerts about this publication. In addition, the AOA produces an online news publication, The DO.
