SCHOLARSHIPSTHE FOUNDATION IS THE WORLDWIDE LEADER OF DIETETICS SCHOLARSHIPS, AND LOOKS TO KEEP PACE WITH A GROWING POOL OF STUDENT APPLICANTS, PROVIDING OPPORTUNITIES AT ALL LEVELS OF EXPERIENTIAL LEARNING AND HELPING TO BUILD A QUALIFIED AND DIVERSE WORKFORCE. THIS PAST YEAR ALONE, NEARLY 234 STUDENTS RECEIVED SCHOLARSHIPS TOTALING NEARLY \$550,000 THROUGH THE(SEE CONTINUATION ON SCHEDULE O) GENERAL SCHOLARSHIP PROGRAM, HOME FOOD SAFETY CHALLENGE SCHOLARSHIPS AND STIPENDS TO ATTEND FNCE AS THE ACADEMY CHARTS ITS SECOND CENTURY VISION FOR THE FUTURE, THE ACADEMY FOUNDATION IS WELL POSITIONED TO RAISE THE NECESSARY FUNDS TO SUPPORT THESE INNOVATIVE PROJECTS, ALONG WITH THE CURRENT INITIATIVES OF THE FOUNDATION - SCHOLARSHIPS, AWARDS, RESEARCH, AND PUBLIC EDUCATION - IN A BROADER, MORE VISIBLE, AND GLOBAL WAY. AWARDSLEADERSHIP AWARDS GIVEN TO STUDENTS, PRACTITIONERS AND FACULTY RECOGNIZE THE OUTSTANDING ACHIEVEMENTS OF ACADEMY MEMBERS, ENCOURAGING INDIVIDUALS TO GROW AS PROFESSIONALS AND ACHIEVE EXCELLENCE IN NEW AND DEVELOPING AREAS OF FOOD AND NUTRITION. THE FOUNDATION PROVIDED \$56,705 LAST YEAR IN THE FORM OF PUBLIC EDUCATION, GRANTS, EDUCATION STIPENDS, RECOGNITION AND LEADERSHIP AWARDS. RESEARCHTHE FOUNDATION'S RESEARCH INVESTMENT IN EMERGING AREAS, SUCH AS NUTRITION EDUCATION INTERVENTION, ADVANCES THE ACADEMY AND ITS MEMBERS AS THE NUTRITION EXPERTS THIS PAST YEAR, \$201,850 WAS MADE AVAILABLE THROUGH THE FOUNDATION RESEARCH EFFORTS. FUNDS RAISED FOR RESEARCH, ESPECIALLY THOSE RELATED TO CHILDHOOD OBESITY HAVE A DIRECT IMPACT ON CONSUMERS BY PROVIDING THEM WITH THE MOST RELEVANT AND ACCURATE FOOD AND NUTRITION INFORMATION. THE FOUNDATION PROVIDES SEED MONEY TO ACADEMY MEMBERS TO CONDUCT PILOT STUDIES AND COLLECT INITIAL DATA THAT CAN BE USED TO SECURE ADDITIONAL GRANTS. PUBLIC EDUCATIONBUILDING UPON ITS CURRENT INITIATIVES, THE FOUNDATION CONTINUES TO EXPAND ITS PROGRAMS, SUCH AS KIDS EAT RIGHT AND FUTURE OF FOOD, WHICH PROVIDE VALUABLE INFORMATION TO THE GENERAL PUBLIC WITH RESOURCES FOR MEMBERS TO DELIVER INFORMATION IN THEIR COMMUNITIÉS KIDS EAT RIGHTTHE ACADEMY OF NUTRITION AND DIETETICS FOUNDATION IS COMMITTED TO PROMOTING A HEALTHY TODAY AND TOMORROW FOR OUR CHILDREN. THE KIDS EAT RIGHT CAMPAIGN WAS LAUNCHED TO SUPPORT PUBLIC EDUCATION PROJECTS AND PROGRAMS THAT ADDRESS THE NATIONAL HEALTH CONCERN OF OBESITY AMONG OUR CHILDREN. KIDS EAT RIGHT POSITIONS ACADEMY MEMBERS AS THE NUTRITION MESSENGER TO BOTH CONSUMER AND PROFESSIONAL AUDIENCES AND GIVES ACADEMY MEMBERS THE OPPORTUNITY TO DIRECTLY IMPACT THE HEALTH OF CHILDREN TODAY. THE CAMPAIGN ENCOMPASSES MANY ELEMENTS THAT PROVIDE GRANT OPPORTUNITIES FOR ACADEMY MEMBERS TO IMPLEMENT PROVEN PROGRAMS IN THEIR COMMUNITIES BY BECOMING CAMPAIGN VOLUNTEERS. THIS PAST YEAR, \$35,000 THROUGH THE KIDS EAT RIGHT PROGRAMS WAS PROVIDED TO INDIVIDUALS AND ORGANIZATIONS.
