MIAD was founded in 1974 and is accredited to offer the Bachelor of Fine Arts degree by the Higher Learning Commission and the National Association of Schools of Art and Design. The college offers five majors to its 609 full and part-time students: Industrial Design, Communication Design, Illustration, Interior Architecture + Design and New Studio Practice - Fine Art. Liberal Studies are required, and the college offers numerous minors, including new minors in Furniture Design, Book Art and Digital Media. In 2016, the college was named a Top Design College by Graphic Design USA, and its Industrial Design program was ranked among the top ten in the country. The college's comprehensive and required Service Learning Program was groundbreaking when founded nearly 15 years ago.
