Explanation: Our original filing was made on 1 May 2016, which was rejected because of having the incorrect accounting period. We were then able to ascertain that our accounting period ended on 31 May 2016, which falls within the summer semester at the University of Illinois. Engineering Employment EXPO, being a student-run organization, was not actively meeting during the months of May, June, July, and most of August 2016 due to this reason. As soon as the Fall semester began, the committee was focused on executing the Fall 2016 EXPO (19-20 September 2016). Having classes five days a week (and exams and assignments) in addition to performing our duties as members of EXPO made it logistically impossible to assemble the requisite documents and prepare the tax return on time. Once EXPO ended, the treasurers were able to gather the documents and properly analyze the income and expenses to prepare this return. Now that we know that the accounting period ends on 31 May, we will be better prepared to address the challenge of completing the return after returning from summer semester and filing it on time.
