USAC administered and facilitated Specialty Programs for over 3596 U.S. university students at 26 sites in 15 foreign countries. The Programs range in length from 3 weeks to a full academic year. USAC programs deliver affordable study abroad opportunities while fulfilling the goal of providing our students with the opportunity to develop the knowledge, inter-cultural competencies and skills to succeed in the 21st century. USAC students participated in programs located in Brazil, Chile, China, Costa Rica, Czech Republic, England, France, Germany, Ghana, India, Ireland, Italy, Spain and Thailand. Enrollments increased 15% in 2015-16 over the prior year.

USAC partnered with over 21 foreign universities to provide an academic education and internationalization for over 733 students. Students participated in programs that ranged in length from 4 weeks to a full academic year at universities in Australia, England, Ghana, Ireland, Israel, Japan, South Korea, Netherlands, New Zealand, Norway, Scotland, South Africa, Sweden, and Turkey. Enrollments increased 14% in 2015-16 compared to the prior year.

USAC offers optional classes, educational tours and field studies with all its Specialty Programs as part of a well-rounded study abroad experience. The tours offer cultural, historical and often political enrichment in the country of your studies.
