IN ALL, THE UNIVERSITY OFFERS DEGREES IN 30 PROGRAMS. STUDENTS PARTICIPATE IN, AND ARE EXPOSED TO, VARIOUS CULTURAL ARTS PROGRAMS AND EVENTS.
