Tuition discount, grant and scholarship reports are submitted to the President on a regular basis. The budget for these grants is approved by the Board of Trustees on an annual basis. The Dean of Admissions and Financial Aid and the Director of Financial Aid monitor all tuition discount financial aid awards prior to the award letter being mailed. Athletic grants are monitored by coaches and the Athletic Director with strict guidelines established by NCAA. The Athletic Director reports regularly to the President of the college the amount of tuition discount athletic grants awarded by each team per year.
