Instruction and Academic Support The 2016 fiscal year for Anderson University (AU) saw a number of new records achieved signaling a 13th straight year of growth across the board in facilities, enrollment, program offerings and external recognition A record freshman class of nearly 800 students helped push enrollment beyond the 3,400 mark, meaning AU essentially doubled in enrollment from 2005 to 2016 Each successive year saw a new enrollment record reached and 2016 was no different In addition, the graduate program reached the 500 mark in enrollment marking a sixth straight year of growth AU is also in the rare position of having steadily increased the academic profile of each successive freshman class while increasing enrollment numbers, something virtually unheard of among private universities of this size AU completed the largest building project in school history as the G Ross Anderson Jr Student Center opened in the fall, immediately transforming life on campus for Anderson students Besides containing a new dining commons, fitness center, movie theater, retail food outlets such as Chick-fil-A and Einstein's Bagels, and a new university bookstore, the sprawling 90,000-square-foot facility has proven the literal heart of campus life as students gather, study, eat, play and visit student life and career services offices from early in the morning until late at night This year, AU entered a new classification in the U S News & World Report rankings AU left the regional colleges category and entered the more competitive Regional Universities classification, landing in the top tier of that ranking in it's first year In addition, the same publication listed as a "Best Value School" for it's combination of academic quality and affordability Anderson was also named an "Apple School of Distinction" for the second time Very few institutions of higher learning worldwide are given such a distinction by Apple once, but to win the accolade twice is extremely rare AU's Mobile Learning Initiative, using mobile devices to transform the learning experience inside and outside of the classroom attracted the attention of the technology giant AU's Center of Excellence in Mobile Learning has been sharing that innovation with public schools systems from across the state so that more students can benefit from mobile technology

Auxiliary Enterprises and Student Services The student experience on campus reached its liveliest point yet in 2016 Additional shuttle buses were added to make transit around the ever-expanding campus easier for students The campus also added a new living arrangement for students as the university obtained a second set of townhomes near the athletic campus for students who prefer a different type of housing experience Twenty townhomes were a part of the initial phase and 20 more were added over the summer for a total of 40 In addition, students were treated to a record number of recreational activities throughout the school year More than 200 to be exact, ranging from ski trips to dances, carnivals featuring real carnival rides to a true Southern hoedown, with an actual mechanical bull
