Instruction For the Academic year 2015-16, enrollment remained steady with 3,596 undergraduate and graduate students completing traditional, online, and hybrid courses 663 degrees were conferred during the year, and the total number of full-time professors was 168 We offer 48 undergraduate degrees and 8 graduate degree programs with more graduate programs under development, including a Masters in Athletic Training, a Masters in Psychology, a Masters in Biology, and a Physician Assistant program CSU offers more than 800 courses, and approximately 142 are available online (Continued on Schedule O)(Continued from Part III, line 4a) Deans and senior administrators are continually in touch with local employers and we are striving to develop new programs that will bndge the identified gaps in the local workforce Continuous campus growth is evident, the new addition to the student dining hall was completed in May, dorm renovations continue throughout the year, and we are about to break ground on a new Health Sciences building to house the future Physician Assistant program CSU partnerships have expanded to several South Carolina school districts outside of the Low country We have offered more than 30 online and traditional professional development courses in gifted and talented and reading literacy during the past year with a record enrollment again this year The School of Education has also partnered with local private high schools to offer dual enrollment to students who are interested in transferring to CSU after they graduate from high school CSU is developing a Physician Assistant program, and the Athletic Training program is now a master's level program Planning continues for the Family Nurse Practitioner program through a grant with the Blue Cross Blue Shield Foundation of South Carolina New majors in Christian Studies and concentrations in Kinesiology are also being offered in the fall 2016 The recently approved ELI program will provide opportunities for all students to have an exponential based learning initiative through courses, new programs, and existing field, clinical-based, and practicum experiences Local and regional outreaches in various disciplines continue, including partnerships with the regional public schools for both student learning and professional development opportunities for teachers and administrators Global study opportunities also exist with a number of faculty leading summer experiences in various regions around the world New program leadership and efforts for expanding the CSU mission abroad continue, in addition to study abroad opportunities Summer camps for English language immersion and increased programming to attract international students to CSU and the Low Country continue, as well CSU has created a Global Education office We will host our first ESL camp this summer for students from China and Taiwan Several professors have led international trips to grow our outreach and recognition in the global academic world This year they have traveled to South Africa, the Dominican Republic, Austria, Hungary, China, Thailand, Canada, and other eastern European countries to spread the word about our students, our programs, and our possibilities CSU was named to America's 100 Best College Buys and America's Best Chnstian Colleges by Institutional Research & Evaluation, Inc The list identifies outstanding Christian Colleges offering high quality education at the lowest possible costs Our Bachelor of Science degree in Organizational Management was ranked 16 in online college programs by U S News and World Report CSU awards institutional, state, NCAA and federal financial aid to a rapidly growing student population representing an increase in numbers and academic quality Approximately 95% of the student population receives some type of financial assistance

Student services Enrollment services, Campus Ministries, Career Center, Counseling Services, Recreational Services, and Residence LifeCSU students continue to log thousands of hours of community service working on projects such as Habitat for Humanity, Christmas Shoe Boxes, student internships, Walk for Water Missions, and the Low country CERT team We continue to see lives changed at CSU! This past year we had 44 students accept Christ, and 68 rededications (Continued on Schedule O)(Continued from Part III, line 4b) Our weekly student-led worship service, called Elevate, had high attendance of 401 and averaged well over 200 for the year Our students were also very involved in mission work We had 2 teams from CSU go to the Far East over Christmas break, 12 students attended the Spring Break Mission Trip to Florida, SEND North America partnership with NAMB has been strengthened, and students are being appointed for summer missions from the Philippines to Lake Tahoe So, we have had over 100 faculty, staff and students involved in mission work this year! We have had as many as 30 discipleship groups, called D-groups, average from 3-40 students per group The Career Center seeks to help students discover their God-given talents and gifts to decide on a major The Career Center also works closely with the QEP implementation of our Exponential Learning Initiative This department also helps to coordinate community service and volunteer opportunities and logged thousands of hours of service The Career Center also facilitates the Bucareer Network that serves students and alumni in job placement We have two licensed professional counselors that met with 185 individual clients this semester Over 850 appointments were met for a range of counseling services including consultation, trnage, intake/assessment, individual counseling, couples, groups, and Safe Harbor Counseling Services also provided programs to help our student body thrive with such programs as Arrive Alive (alcohol and impaired driving prevention), Suicide Prevention Week, Body Image Week, and Stressbusters We also started working with the VA to bring the VITAL initiative (mental health counseling for veteran students) onto the CSU campus Recreational Services has seen a tremendous increase in participation The total 2014-15 academic year intramural participants was 589 The total for 2015-16 intramural participants was over 875 We offer intramural sports, exercise classes, spin classes and other opportunities to encourage our students to stay active and healthy Residence Life attendance for the fall 2015 semester was 1,292 and 1,166 for the spring 2016 semester Residence Life Residential Advisors (RAs) served approximately 200 hours at the Low Country Pregnancy Center The departmental mission for Residence Life is to create a community that honors God, and enables students to thrive The focus is on four key areas Jesus, Neighbor, Community, and Disciples This coming summer could be the strongest summer camp participation in the history of CSU There are 13 different groups attending CSU this summer, and our anticipated Mission-Fuge 2016 attendance should be over 3,000 students These summer groups equate to over 3,600 prospective students

This is not treated as taxable compensation. All perquisites indicated above have been instituted by the governing board of the University.
