The process requires the President to complete a Self-Assessment and the Board of Trustees members to complete performance Assessment Forms. The Compensation Committee reviews the assessment and prepares a recommendation for the Executive Committee. The Executive Committee reviews the deliberations with the Board of Trustees. The President evaluates and determines the compensation of each Senior Officer using AICAD data and the results of the performance review. The Vice President for Finance and Administration, the Vice President for Academic Affairs, the Vice President for Human and Organizational Development, the Vice President for Advancement, and the Vice President for Student Life are Senior Officers. It is the policy of the College to evaluate the effectiveness of all staff through the performance evaluation process. Each Senior Officer completes an annual report for the President's review. The President reviews the comparative data for each of the Senior Officers with the Compensation Committee. Documentation includes notes taken at the Compensation Committee of data review and deliberations. Annual assessment documents for the President are also maintained.
