The Junior League of Jackson evaluated and strengthened its Issue Based Community Impact Model by reframing the areas in which the League is working The reframing was designed to further educate members, corporate sponsors, and community partners about how the League works to maximize our presence by placing funds and volunteer hours into areas of critical need in the community Annually, the League organizes 30 projects to serve our community, focusing on the issues of Early Literacy, Health, and Social Development The League hosted a Community Roundtable for local nonprofit leaders aimed at helping local non-profits navigate advocating issues important to their missions Experts in health advocacy joined us to share their expertise and experiences in health advocacy "Junior League of Jackson volunteers planned and led five summer camps focused on the issues of Early Literacy, Health, Social Development, and Teenage Pregnancy Prevention These projects served students from the Jackson area and included activibes in reading, writing, math, music/drama, physical fitness, arts/crafts, and conflict resolution Lessons also focused on the importance of staying in school Additionally, volunteers coordinated meals and snacks, motivational assemblies, and field trips The Junior League of Jackson partnered with the Community Foundation of Greater Jackson to award over \$100,000 in grants in support of special projects and lessons submitted by Jackson Public School teachers Junior League of Jackson volunteers partnered with the Mississippi Food Network to pack and deliver close to 5,000 backpacks with nutritious food for children and their families at Brown and Johnson Elementary These families were identified by school nurses and teachers as being "food insecure" outside of school In addition, volunteers packed boxes of food for families at Thanksgiving The Ultimate Rummage Sale, the Junior League Jumble, was held for the second year Jumble, which serves as both a community and fund development project, provides shoppers the opportunity to purchase gently used merchandise at bargain prices In addition, our annual Touch A Truck Jackson event was held in the spring at Trustmark Park Volunteers helped over 700 children from local schools explore different trucks and equipment during our inaugural Field Trp Frnday The funds raised on Saturday through this dual community and fund development project help support the mission of the League while providing a unique experience for children and families in the Jackson area
