BOGUS BASIN IS A RECREATIONAL AREA THAT OPERATES TO ENRICH THE LIVES OF TREASURE VALLEY RESIDENTS BY PROVIDING YEAR-ROUND OUTDOOR ACTIVITIES AT RATES THAT ARE AFFORDABLE TO A SIGNIFICANT PART OF THE COMMUNITY. BOGUS BASIN HAD 320,000 WINTER VISITS AT AN AVERAGE ADMISSION COST PER VISIT OF ONLY \$24.97, A RATE SIGNIFICANTLY LOWER THAN SIMILAR SKI AREAS. BOGUS BASIN OFFERS NORDIC SKIING, TUBING, AND SNOW SHOEING DURING THE WINTER AND HAD OVER 340,000 TOTAL VISITS DURING THE FISCAL YEAR.
