This was not neglectful or careless on Regent College Foundation's part, the lack of filing the extension was just an administrative error on the part of the outside accountants. What steps have been taken to prevent the same situation from occurring in the future: the outside accountants have systems in place for all existing organizations to insure that extensions are filed timely.
