The University comprises two schools: the College of Social Sciences, which offers degrees in Humanistic and Clinical Psychology, Counseling (M A ), Leadership and Management (M A and Ph D in Organizational Systems and Management), and Transformative Social Change (M A and Ph D ), and the College of Integrative Medicine and Health Sciences, which offers degrees in Mind-Body Medicine (M A and Ph D ) and Integrative and Functional Nutrition (M S ). The University also offers certificates, continuing education, and professional studies in several of these areas. The learning model includes online-hybrid and residential formats. Saybrook served approximately 600 students during the fiscal year ending in May 31, 2016.
