TUITION AND FEES Alaska Bible College (ABC) is a small, missions-based, accredited Bible college located in the small community of Palmer in southcentral Alaska. ABC serves 42 students and offers degree and certificate programs which will encourage further development and training in the church or graduate studies. The 4-year Bachelor of Arts degree program provides basic and advanced equipping for ministry or further study in a graduate program. Each B.A. student is a Biblical Studies major and a Christian Ministries second major, with a possible option of choosing an Educational Ministries, Missions, or Pastoral emphasis. The Associates of Arts degree is designed for the student who desires a strong biblical foundation in preparation for further study at another college or effective ministry within the local church. A core of Bible, ministry, and general education courses enable the student to gain a solid foundation for life and ministry. The Bible and Ministry Certificate is a two-year program designed for the student who desires a strong biblical and ministry foundation in preparation for effective ministry within the local church and community. The Bible Certificate is designed for a student who desires a basic understanding of the Bible to prepare for college experience elsewhere or to meet Bible requirements in preparation for missionary service. In addition, the Bible Certificate is intended for students who are unsure of their future and desire basic Bible knowledge. Program expenses include current research material and books in ABC's Ball Memorial Library - Alaska's largest collection of theological books, up-to-date computers, a work-study program and financial aid, and a variety of activities in the Murdock Campus Center, which contains a lounge, gymnasium, and fitness center.

AUXILIARY SERVICES The majority of full-time students live in the campus dormitories. Dorm students usually eat together in the food cache (cafeteria), which also provides a comfortable atmosphere for social and leisure activities.

BROADCASTING The College, designated by the Federal Communication Commission as a public service, operates a radio station that broadcasts various forms of programming including Christian music and programming designed to bring listeners to a knowledge of Christ and educate/disciple them, national and local news, public service announcements and a personal message service for those without two-way communications in remote areas of the Copper River Basin, and live broadcasts of area high school sporting events.

The qualify, a student must be enrolled full-time (12+ credits) in a degree or certificate program, must maintain a 2.0 GPA, and must maintain a current financial account with the Business Office. Students complete and submit an application along with financial information to help a committee determine each student's financial need. Decisions are made by the committee and awards are given after the 6-week grade check each semester.
