Community-Based Services Maine Family Planning (MFP) provides funding, technical support, and quality assurance to 27 clinics statewide, in addition to offering direct services at 18 clinics in Augusta, Bangor, Belfast, Calais, Damariscotta, Dexter, Ellsworth, Farmington, Fort Kent, Houlton, Lewiston, Machias, Norway, Presque Isle, Rockland, Rumford, Skowhegan, and Waterville Using a sliding-fee scale, MFP serves 22,395 low-income Maine women, men, and teens annually with expert and confidential services that include - comprehensive and medically accurate reproductive health care information to help clients make informed decisions about their reproductive health and lives, - gynecological exams, - pregnancy testing and options counseling, - family planning, including first-trimester medication and aspiration abortion care services, - emergency contraception, - STD and HIV testing and treatment, - screenings for reproductive cancers, and - colposcopy for evaluation of abnormal Pap tests MFP administers a WIC program in Washington and Hancock county The WIC program provides nutritious foods, nutrition education (including breastfeeding promotion and support), and referrals to health and other social services to participants at no charge WIC serves low-income pregnant, postpartum and breastfeeding women, and infants and children up to age 5 who are at nutrition risk

Education and Research Projects Designed with input from Maine teens, www.maineteenhealth.org provides sexual health information, a guide to Maine’s family planning clinics, and an interactive place to get answers to their sexual health questions MFP’s text messaging service, AskMTH, allows teens to use their cell phones to text anonymous questions and get answers from a trained family planning professional The Teen Pregnancy Prevention Program, Prevention Coordinators worked with educators in 28 schools and community based organizations statewide to help them deliver a variety of evidence-based, comprehensive sexuality education curriculums focused on preventing HIV/STDs and pregnancy, reaching nearly 1,500 youth To sustain and improve the quality of sexuality education delivered in Maine, the Prevention Program provides training and professional development to educators through in-person trainings, an annual conference and education e-blasts MFP’s Teen Pregnancy Prevention Program also continued its work through the federally funded Personal Responsibility Education Program (PREP), partnering with Jobs for Maine’s Graduates (JMG) to deliver evidence based programming During the 2015-16 school year, 491 students participated in the All4You! curriculum in 24 high schools located in Maine communities with high teen pregnancy rates Evaluations showed increased knowledge and improved attitudes around HIV/STDs, pregnancy prevention, and behaviors that put teens at risk and preventive measures like abstinence, birth control and condom use Similar to our community-based services, funding for MFP’s education and research projects is provided by state and federal agencies (that also monitor program operations and outcomes), foundation grants, and other restricted revenues

Agency and Mission-Related Projects Since 1971, MFP’s Public Affairs staff has worked to protect the reproductive rights of all Maine citizens MFP is founded on the premise that Maine women and teens must have access to comprehensive reproductive health care and information in order to control their reproductive lives MFP’s Public Affairs efforts are designed to promote and protect programs and services statewide to ensure affordable access to family planning Each new legislative session brings new legislators that require education to dispel myths about reproductive health care and rights, and to help them recognize reproductive health care as basic health care, rather than simply a political issue We continue to rely on a strong network of pro-choice, pro-family planning grassroots activists who communicate very powerfully with their elected representatives, and will continue to be vigilant in protecting and expanding access to the full range of reproductive health care for all women, men and teens in Maine Private contributions and agency-endowed resources fund these projects No public funds are used
