The trade missions provide one-on-one meetings with potential foreign trade partners and unique networking opportunities. Trade missions are particularly useful for first time exporters or companies having difficulty expanding into a particular country or market. The Trade Center arranges all details of the missions including transportation, translators, and business meetings.

Technical Assistance & Trade Counseling The Trade Center assists its members in researching new markets, reviewing trade regulations, tariffs and logistics, and in product sourcing. There are a number of resources we have available to the public in our Portland Trade Library, and on our website where trade news and current export data is listed. We have extensive internet research capabilities and on-line database services along with internet reference guides that provide our members with timely information on foreign markets.

Part I, Line 2	The process used for the disbursement of grant funds to foreign based organizations requires that a Request for Proposal (RFP) is written by Maine International Trade center (MITC) and candidates are sought to submit their proposals based on the specifications of work proposed in the RFP. The candidates must outline in detail how they will meet the reporting guidelines and objectives and submit their quote of services for review. A committee is formed by MITC that reviews the applications and narrows down the candidate's for final vetting and approval to enter into a contract. The foreign based consulting company that is selected then signs a contract agreement for services with MITC and is required to submit monthly performance reports and invoices during the pre-determined execution period for the grant funding. On a monthly basis the reports are reviewed by the Director in charge of the overseas activity and once the report is accepted they would then authorize financing to make payment by wiring funds to the foreign based organization. All supporting documentation is kept by the finance department as backup. On a quarterly basis MITC submits to the grant issuing organization a request for reimbursement based on the fully executed grants that were paid in that quarter.

On a quarterly basis MITC submits to the Grant issuing organization (SBA, etc) a request for reimbursement based on the fully executed Grants that were used in that quarter. Once funding is received by the grant issuing organization the authorization is then given by the Vice President of finance to reimburse the company for their expenses.
