 Public Outreach - Includes responding to public information requests and social media outreach to inspire more to register as donors. As of June 30, 2016, the Facebook page had 9,916 followers. Donate Life uses Facebook to reach constituents and others who have an interest in organ, eye and tissue donation.

 DMV Outreach - Focuses on educating Division of Motor Vehicles Examiners and State-level leaders about the important partnership between the NC Donor Registry and Donate Life NC. We also provide information and volunteers through the DMV offices to educate the public as they get ready to be asked whether they want to register as a donor when they get their driver's license. There are 545 DMV Examiners and we trained about 100 new ones this past year. We have 60-75 volunteer DMV Ambassadors who have visited those offices quarterly, updating materials and sharing data on office donor designation rates. By the end of June 2016, more than 4.7 million North Carolina donors were registered through the DMV.

 Teen Outreach - Focused on educating teens and teen educators about organ, eye and tissue donation before a teen gets their first driver's license. We have provided training on the Donate Life NC teen curriculum to more than 1,200 educators in the past fiscal year.
