For receivables associated with self-pay patients (which include both patients without insurance and patients with deductible and copayment balances due for which third-party coverage exists for part of the bill), the Organization records a provision for bad debts in the period of service based on past experience, which indicates that many patients are unable or unwilling to pay amounts for which they are financially responsible. The difference between the standard rates (or on the basis of discounted rates, by State law, or provided by policy) and the amounts actually collected after all reasonable collection efforts have been exhausted is charged against the allowance for doubtful accounts. During 2016, the Organization increased its estimate from \$3,902,231 to \$4,793,706 in the allowance for doubtful accounts relating to self-pay patients and during 2015 the Organization decreased its estimate from \$4,129,465 to \$3,902,231 in the allowance for doubtful accounts relating to self-pay patients. During 2016, self-pay write-offs decreased from \$5,771,998 to \$5,244,510 and during 2015 self-pay write-offs decreased from \$7,488,563 to \$5,771,998. Such changes in write-off amounts resulted from trends experienced in the collection of amounts from self-pay patients and the aging of the receivable balances.
