WE BEGAN IN 1816 BY A SMALL GROUP OF WOMEN WHOSE GOAL WAS TO FEED THE FAMILIES OF FISHERMEN IN PORSTMOUTH, NH. WE HAVE GROWN TO BECOME A NEARLY \$500,000 ORGANIZATION. ORIGINALLY NAMED THE LADIES HUMANE SOCIETY, WE CHANGED OUR NAME IN 2007 TO BETTER REFLECT THE SERVICES WE OFFER IN OUR COMMUNITY. OUR FOCUS IS NOT ONLY TO PROVIDE FOOD AND BASIC NECESSITIES BUT TO INSPIRE, ENCOURAGE AND TEACH OUR FAMILIES HOW TO MAKE NUTRITIONALLY SOUND FOOD CHOICES AND PREPARE HEALTHY MEALS. IN THE FISCAL YEAR 2016 (JULY 1, 2015-JUNE 30, 2016), THE SFFP SERVED 4,373 HOUSEHOLDS. PROGRAMS INCLUDED GENERAL ACCESS TO THE FOOD PANTRY AS WELL AS SEVERAL DISTINCT PROGRAMS 1) SUMMER MEALS FOR KIDS - IN RESPONSE TO THE PARTICULAR CHALLENGES FACED BY THE CHILDREN AND YOUTH IN OUR REGION, WE RE-DESIGNED OUR SUMMER MEALS PROGRAM AND LAUNCHED OUR NEW SUMMER MEALS 4 KIDS (SM4K) PROGRAM IN FISCAL 2015. IT HAS BEEN A TREMENDOUS SUCCESS BY ADDING MOBILE OPTIONS AND WORKING CLOSELY WITH OUR COMMUNITY PARTNERS, WE ARE REACHING THE MOST VULNERABLE CHILDREN IN OUR AREA. THE SM4K PROGRAM HAS THREE MAJOR OBJECTIVES: TO REACH THOSE CHILDREN WHO FACE HUNGER DURING TIMES WHEN SCHOOL MEAL PROGRAMS ARE UNAVAILABLE, TO ENCOURAGE A FOCUS ON MAKING NUTRITIOUS CHOICES AND A MOVEMENT AWAY FROM UNHEALTHY, PREPACKAGED ITEMS THAT CAN LEAD TO OBESITY AND, TO TEACH LONG LASTING SELF-SUFFICIENCY SKILLS TO CHILDREN (ESPECIALLY THOSE THAT LACK PARENTAL SUPERVISION) BY INSTRUCTING THEM ON HOW TO COOK HEALTHY MEALS FOR THEMSELVES USING MICROWAVE-FRIENDLY RECIPES/INGREDIENTS. THE SM4K PROGRAM DELIVERS THE PROGRAM ON SITE AT SEVERAL LOCATIONS AROUND THE SERVICE AREA, ELIMINATING THE NEED FOR TRANSPORTATION TO THE AGENCY TO ACCESS THE FOOD AND PROGRAM ELEMENTS. INFORMATION ON THE PROGRAM CAN BE FOUND AT WWW.SUMMERMEALS4KIDS.ORG 2) COMMUNITY SUPPORTED AGRICULTURE (CSA) - THE SFFP PARTNERED WITH WAKE ROBIN FARM TO PURCHASE 20 SHARES, SERVING 20 FAMILIES. THE PREMISE OF THE CSA PROGRAM IS TO ALLOW PARTICIPATING FAMILIES A STAKE IN FARM TO TABLE QUALITY FOODS BY PURCHASING SHARES OF THE FARM'S HARVEST BEFORE THE SEASON STARTED. IN RETURN, PARTICIPATING FAMILIES WERE ABLE TO PICK UP THE FRESHEST POSSIBLE VEGGIES ON A WEEKLY BASIS THROUGHOUT THE GROWING SEASON. FAMILY MEMBERS BECOMING A MEMBER IN THE CSA PROGRAM TOOK AN ACTIVE ROLE IN PRESERVING THE SUSTAINABILITY OF LOCAL FARMING, KEEPING YOUR FOOD DOLLARS IN THE LOCAL ECONOMY, AND REDUCING THE AMOUNT OF FUEL USED TO SHIP FOOD 3) HOLIDAY DISTRIBUTION - THE SFFP ORGANIZES SEVERAL HOLIDAY ORIENTED FOOD DISTRIBUTION DRIVES INCLUDING THE 4TH OF JULY, THANKSGIVING AND CHRISTMAS. BAGS OR BASKETS OF HOLIDAY THEMED FOOD WAS ASSEMBLED AND DISTRIBUTED ON SITE AT THE AGENCY. THESE PROGRAMS SERVED 700 INDIVIDUALS. THE SFFP BENEFITS FROM STRONG COMMUNITY SUPPORT, BOTH MONETARY AND THROUGH FOOD AND PRODUCT DONATIONS. IN ADDITION TO REGULAR DONATIONS TO THE AGENCY BY INDIVIDUAL AND LOCAL BUSINESSES, THE SFFP ORGANIZED SEVERAL COMMUNITY BASED FOOD DRIVES, INCLUDING THE FIRST TIME EVENT, FILL THE HALL. FILL THE HALL WAS A PARTNERSHIP WITH PORTSMOUTH MUSIC HALL AND THE GOAL WAS FOR FOOD DONATIONS TO BE DROPPED OFF AT THE MUSIC HALL FILLING 1000 SEATS. FILL THE HALL WAS AN EXTRAORDINARY SUCCESS AND RESULTED IN MORE THAN FIVE TONS OF DONATED FOOD. IN ADDITION TO THE SUPPORT DESCRIBED ABOVE, THE SFFP IS THE RECIPIENT OF FUNDS THROUGH A VARIETY OF LOCAL FUNDRAISING EVENTS, SOME ORGANIZED BY BUSINESSES, CIVIC GROUPS AND CHURCHES, AND OTHERS ORGANIZED BY THE AGENCY ITSELF. OVERALL, THE SFFP IS HONORED TO SERVE THE COMMUNITY AND IS BOTH THANKFUL FOR, AND WOULD BE UNABLE TO MEET THE NEEDS OF OUR RESIDENTS, WITHOUT THE ONGOING SUPPORT FROM INDIVIDUALS, BUSINESSES, CHURCHES, CIVIC GROUPS AND FUNDERS.
