SEE SCHEDULE ODURING FISCAL YEAR 2016, THE LYME FOUNDATION HELPED THE TOWN OF LYME WITH GRANTS FOR A NEW WEBSITE, A NEW ADA LIFT IN THE LIBRARY AND IMPROVEMENTS TO THE GARDEN AT THE TOWN OFFICES. THE FOUNDATION SUPPORTED THE HIRING OF A NEW PART TIME NURSE TO RESPOND TO THE INCREASING NEED IN THE TOWN FOR COMMUNITY HEALTH AND NURSING. THE LYME HISTORIANS WERE RECIPIENTS OF A LARGE GRANT TO CONVERT THEIR NEWLY PURCHASED DOWNTOWN RESIDENTIAL BUILDING TO A MUSEUM AND OFFICES. THOSE GUYS SUPPORTS THEIR COMMUNITY SERVICE ACTIVITIES BY RENTING TENTS FOR EVENTS, THE FOUNDATION GRANTED THEM FUNDS FOR A NEW TENT. EMERGENCY SERVICES WERE ADDRESSED BY FUNDING A GENERATOR PURCHASE AT THE LYME NURSERY SCHOOL AND EMERGENCY BAGS WHICH WERE DISTRIBUTED BY THE FAST SQUAD TO LYME RESIDENTS. THE HAVEN'S SHELTER PROGRAM AND THE EFFORT TO BRING FIBER OPTIC SERVICE TO EVERY HOME IN LYME WERE ALSO SUPPORTED BY THE FOUNDATION. THE GRIFFITH FUND WAS USED TO FUND AWARDS TO 16 STUDENTS. THE CHAFFEE FUND AWARDED GRANTS TO SIX FAMILIES IN NEED. THE DIMICK FUND PROVIDED SUPPORT TO 19 INDIVIDUALS IN NEED, INCLUDING GRANTS FOR RENT AND FUEL ASSISTANCE. FROM THIS FUND, 25 ELDERLY OR NEEDY FAMILIES RECEIVED A SMALL CASH GIFT AT THE END OF THE CALENDAR YEAR. THE LYME CITIZEN OF THE YEAR WAS ACKNOWLEDGED WITH A CASH AWARD FROM THE MILLER FUND.
