COMMUNITY DEVELOPMENT PROGRAM PROVIDES GRANTS AND SERVICES TO SUPPORT EFFORTS BY COMMUNITIES TO MAKE THE ARTS PART OF EVERYDAY LIFE AND TO INCREASE PUBLIC AWARENESS OF THE POSITIVE ROLE PLAYED BY ARTISTS AND ARTS ORGANIZATIONS IN THEIR COMMUNITIES. 46 GRANTS WERE AWARDED TO ARTS ORGANIZATIONS, ARTISTS, AND COMMUNITIES, INCLUDING THE SECOND YEAR OF A NEW THREE-YEAR UNRESTRICTED OPERATING GRANT PROGRAM FOR ARTS PARTNERS. GRANT-SEEKERS AND CULTURAL FACILITIES WORKSHOPS WERE HELD. AN ACCESS CONSULTANT HELPED CULTURAL FACILITIES APPLICANTS WITH ACCESS ISSUES IN THEIR APPLICATIONS. TWO ART IN STATE BUILDINGS PROJECTS WERE PREPARED AND INSTALLED INCLUDING A LARGE MURAL AT THE NEW STATE OF VERMONT WATERBURY COMPLEX. VERMONT'S CULTURAL DATA PROJECT, A POWERFUL ONLINE MANAGEMENT TOOL TO HELP ARTS ORGANIZATIONS IMPROVE THEIR FINANCIAL MANAGEMENT AND SERVICES TO THEIR COMMUNITIES, WAS CONTINUED. AN ACCESS CONSULTANT WORKED WITH STAFF ON SITE VISITS TO ASSIST LOCAL ARTS ORGANIZATIONS WITH THEIR ACCESS ISSUES AND IMPLEMENTATION PLAN UPDATES. A WORKSHOP ON MAKING WEBSITES MORE ACCESSIBLE WAS HELD. A NEW PROGRAM TO PROVIDE TECHNICAL ASSISTANCE TO ARTS ORGANIZATIONS WAS CREATED AND THE FIRST WORKSHOP WAS HELD THIS YEAR.

ARTS CREATION AND PRESENTATION PROGRAM PROVIDES GRANTS AND SERVICES TO SUPPORT THE DEVELOPMENT OF VERMONT ARTISTS AND ARTS ORGANIZATIONS AND TO PROVIDE GREATER OPPORTUNITIES FOR THE CREATION AND PRESENTATION OF EXCELLENT WORK. 62 GRANTS WERE AWARDED TO ARTISTS AND ARTS ORGANIZATIONS FOR PROFESSIONAL DEVELOPMENT AND CREATIVE PROJECTS. "BREAKING INTO BUSINESS" WORKSHOPS HELPED ARTISTS DEVELOP MARKETING AND BUSINESS PLANS. GRANT-SEEKERS, LOCAL ARTS ADMINISTRATORS NETWORKING MEETINGS AND OTHER WORKSHOPS WERE HELD. SCULPTURE GARDEN AND OFFICE GALLERY EXHIBITS SHOWED THE WORK OF VERMONT ARTISTS, AND WERE INCLUDED IN THE LOCAL FIRST FRIDAY ART WALKS. A NEW VERMONT POET LAUREATE WAS SELECTED AND HONORED AT THE ANNUAL GOVERNOR'S AWARDS CEREMONY.

THE COUNCIL ADVOCATES ON THE LOCAL, STATE AND NATIONAL LEVEL TO INCREASE PUBLIC INVESTMENT IN THE ARTS AND ARTS EDUCATION AND TO PROVIDE INPUT ON PUBLIC POLICIES AFFECTING THE CULTURAL SECTOR. THE COUNCIL ALSO CONTINUED ITS USE OF SOCIAL MEDIA NETWORKING (FACEBOOK, TWITTER, YOUTUBE) FOR OUTREACH AND ENGAGEMENT WITH CONSTITUENTS. AN ANNUAL MEETING WAS HELD WHICH WAS OPEN TO ALL. AN ANNUAL AWARDS CEREMONY WAS HELD WHICH RECOGNIZED 9 OUTSTANDING PEOPLE FOR THEIR SERVICE TO THE ARTS, A GOVERNOR'S AWARD FOR EXCELLENCE IN THE ARTS, THE CERF MEDALS FOR OUTSTANDING ACHIEVEMENT, THE MCCULLOCH-LOVELL AWARDS IN ARTS EDUCATION, THE KANNENSTINE AWARD FOR ARTS ADVOCACY, AND THE ARTHUR WILLIAMS AWARD FOR MERITORIOUS SERVICE WERE GIVEN. THE ANNUAL REPORT WAS PUBLISHED AND MADE AVAILABLE IN BOTH PRINT AND ONLINE. PUBLIC AWARENESS OF THE VALUE OF THE ARTS WAS PROMOTED. THE SECOND HALF OF THE 50TH ANNIVERSARY CELEBRATION WAS CONTINUED BY RECOGNIZING THE OUTSTANDING WORK OF ARTISTS AND ARTS ORGANIZATIONS AROUND THE STATE. THE GROUND WORK FOR THE VERMONT CREATIVE NETWORK CONTINUED WITH THE COUNCIL HOSTING THE FIRST ARTS SUMMIT IN NOVEMBER OF 2015.
